## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 - Inquiry posted looking into the start of the race and whether No. 2 PONDA AESTHETIC made the fair start pole. Replay showed that the horse was outside of the pole prior to the rest of the field being released. No. 2 PONDA AESTHETIC declared a non-starter for wagering purposes and refunds issued on any bets made involving the horse.

Race 10 - Inquiry posted on unofficial fourth place finisher No. 5 TOTALLYEXHAUSTED (Joey Putnam) for possible violation of the breaking rule after the start. After reviewing video the judges determined that Mr. Putnam complied with all aspects of the breaking rule and did not make an extended break. No reason for disqualification and the horse was placed as finished.

Race 11 - Tom Luther, driver of No. 6 KJ OWEN, warned about using too much wrist and elbow action while whipping in the stretch.

Race 12 - No. 5 DOVER HILL was programmed with trotting hobbles erroneously and did not race with them.

Race 14 - No. 5 SHAKIN MY PEACHES was first time Lasix. Announcements made via TV scroll and track announcer.
