### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**Race 6** - Inquiry posted regarding the start of the race and whether No. 8 LORI MY LOVE (Kyle Wilfong) made the fair start pole. Replays showed that No. 8 LORI MY LOVE was outside of the fair start pole when the rest of the field was released. The horse was declared a non-starter for wagering purposes and refunds were issued on any bets made involving the horse.

**Race 12** - Inquiry posted looking at an incident in the stretch between unofficial second place finisher No. 3 FLIRTIN FANERA (Ricky Macomber, Jr.) and unofficial third place finisher No. 7 STRAIGHT AND SASSY (Joey Putnam). Video showed No. 7 STRAIGHT AND SASSY bear out in the stretch and hook wheels with No. 3 FLIRTIN FANERA. This was confirmed by both drivers when speaking with the judges. No reason for placing, but Joey Putnam fined \$200.00 for interference.
