**Race 5** - No. 2 STRENGTH OFA SWAN originally finished fifth placed seventh for violation of the breaking rule past the quarter: extended break.


**Race 6** - Separate inquiries posted on both unofficial third place finisher No. 3 TOWNLINE IT IS (Mike Peterson) and unofficial fourth place finisher No. 9 WOOTYISAROCKER (John DeLong) for possible violations of the breaking rule. No. 3 TOWNLINE IT IS broke right at the finish and was not lapped on by other horses. No reason for disqualification. No. 9 WOOTYISAROCKER broke right after the start and driver John DeLong complied with all aspects of the breaking rule. That horse was also placed as finished.





## Harrah's Hoosier Park IHRC Judges' Daily Report

**Race 12** – General inquiry posted concerning the start of the race and whether No. 9 KENDALLSFLYINGHELP made the fair start pole. Replay showed that the horse was inside the pole when the rest of the field was released and therefore the horse was declared an official starter.

**Race 14** - No. 1 FOX VALLEY SCAMPI (Devon Tharps) originally finished eighth placed ninth for interference to No. 8 CASH WITH JOE (John DeLong) past the half. Driver Devon Tharps fined \$200.00 for interference causing a placing.
