Race 4 – Case Bateson, driver of No. 4 MR D'S DRAGON, fined \$200.00 for foot out of the stirrup making contact with the horse.

Race 8 – Inquiry posted on unofficial race winner No. 9 ROCKIN SIS (Brandon Bates) for possible pylon violation after $\frac{3}{4}$ entering the stretch. Video showed that Mr. Bates was inside one pylon and struck another. The judges determined that the horse did not gain an unfair advantage. No reason for disqualification and the horse was placed as finished.
