Race 1 - Inquiry posted on unofficial second place finisher No. 4 MB LOVER BOY (Robert Taylor), unofficial third place No. 7 YO REBECCA (Mike Oosting), and unofficial fourth place finisher No. 5 COUNTRY CUTIE (Trace Tetrick) for possible violations of the breaking rule at various points in the race. All drivers deemed to have complied with the breaking rule and were placed as finished. However, No. 3 SHESPERTIFULIKPERT (Kyle Wilfong) finished fifth placed sixth for violation of the breaking rule in the stretch (extended break).

Race 7 - Tyler Miller, driver of No. 2 LADY ANGEL, reminded of the rule that drivers must adjust their handholds to so the lines are taut.
