Race 8 – Inquiry posted on unofficial race winner No. 10 RIGGINS TIME (Jordan Ross) for possible interference just past the quarter. After speaking with multiple drivers and reviewing the incident the judges determined that while No. 10 RIGGINS TIME tried to pull up, the horse did not cause interference to trailing horses. No. 10 RIGGINS TIME placed as finished.

Race 13 – No. 2 COUNTRY MAMMA (Atlee Bender) originally finished eighth placed ninth for interference to trailing horses while on a break before the half.
