ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 5 – Inquiry posted on unofficial fourth place finisher No. 3 TOPVILLE SWIFT DAN (John DeLong) for possible violation of the breaking rule in the stretch through the finish. Video showed that Mr. DeLong complied with all aspects of the breaking rule. No reason for disqualification and the horse was placed as finished.

Race 7 – Inquiry posted on unofficial third place finisher No. 6 DOJEA ROCK (John DeLong) for possible interference to unofficial eighth place finisher No. 4 VEGAS AGAIN (Brad Ferguson) going up the backside past the quarter. After speaking with both drivers and reviewing video the judges determined that Mr. DeLong never caused interference to Mr. Ferguson. With no reason for disqualification the horses were placed as finished.

Race 9 – Approximate 20-minute delay as the main starting gate would not get into gear and the starter had to switch to the back-up gate. During the delay the horses were sent back to the paddock.

Race 10 – Inquiry posted on unofficial second place finisher No. 5 BOWIE ROCKS (Ricky Macomber, Jr.) for possible interference to trailing horses in the first turn. John DeLong, driver of unofficial fourth place finisher No. 4 ALWAYS AMAZING also filed an objection. Video showed that Mr. Macomber white on the lead, going to the quarter, grab up and cause confusion to trailing horses. For slowing abruptly and causing confusion to trailing horses. No. 5 BOWIE ROCKS finished second placed sixth. Ricky Macomber, Jr. fined \$300.00.
