ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 6 – Inquiry posted on unofficial fourth place finisher No. 7 SWANTANAMO BAY (Rick Plano) for possible pylon violation in the far turn. Video showed that Mr. Plano was inside of pylons at multiple points in the last turn. The first set of pylons he was inside due to outside pressure from No. 11 DOUBLE RACER (Brandon Bates) and therefore there was no reason





for placing. However, exiting the turn and entering the stretch Mr. Plano was well inside two more pylons. With the horse being lapped on at the finish, per IHRC rules, the horse must be disqualified. No. 7 SWANTANAMO BAY finished fourth placed fifth. Driver Rick Plano fined \$200.00 for the pylon violation.


Race 7 – No. 3 FOXY LOAD (Mike Oosting) originally finished sixth placed seventh for violation of the breaking rule in the stretch.

Races 10 – 14 – Races sped up due to worsening air quality brought upon by Canadian wildfires. Trainer were given the option to scratch their horses without penalty all evening.


Race 13 – Inquiry posted on unofficial fourth place finisher No. 8 NOSTALGIC (Dan Shetler) for possible violation of the breaking rule past the 1/4 entering the backstretch. While on the break No. 8 NOSTALGIC interfered with No. 9 SILVER CRAFT (Robert Taylor). However, No. 9 SILVER CRAFT finished third. Therefore with driver Shetler complying with the breaking rule and the only horse that was interfered with finishing ahead of his horse there was no reason for placing.
