ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 - Inquiry posted on unofficial third place finisher No. 6 BET ON BRENNNA (Mike Oosting) for possible violation of the breaking rule nearing the finish. Video clearly shows the horse making a break prior to the finish and was lapped on by one other horse at the wire. For violation of the breaking rule (lapped on break) No. 6 BET ON BRENNNA finished third placed fourth. No penalty to driver Oosting.


Race 5 - No. 1 BEAUTY N GRACE (Atlee Bender) originally finished fifth placed sixth for interference to trailing horses while on a break before the quarter.
