ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 3 - Inquiry posted on unofficial third place finisher No. 2 REAL COOL COLE (Brandon Bates) for interference to trailing horses while on a break. Replay showed that No. 2 REAL COOL COLE was off stride briefly, but while on a break the horse did cause interference to trailing horses; No. 1CASH WITH JOE, No. 6 DANIEL'S SON, and No. 10 LUCKIESTMANALIVE. No. 2 REAL COOL COLE originally finished third placed tenth.

Race 4- Inquiry posted on unofficial third place finisher No. 8 GREATEST SUNSET for possible violation of the breaking rule at the start. Driver Jordan Ross complied with all aspects of the breaking rule and the horse was placed as finished.

Race 10 - General inquiry regrading whether No. 1 MAJORDANCEMOVES (Jordan Ross) made the fair start pole. Video showed that the horse was inside of the pole prior to the rest of the field being released by the starter. No. 1 MAJORDANCEMOVES declared a starter for wagering purposes. However, No. 1 MAJORDANCEMOVES finished fifth placed sixth for violation of the breaking rule (extended break).

Race 14 General inquiry looking into breaking horses entering the last turn before 34. Video showed that all three horses that made breaks did so at about the same time, however they were all independent of each other and did not affect any of the other horses in the race. All horses placed as originally finished.
