### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS




**Race 3** - Inquiry posted on unofficial race winner No. 7 ROCKET LEE BREEZE (JD Finn) for possible violation of the breaking rule before the start. Mr. Finn complied with the breaking rule and did not interfere with any horse. No reason for disqualification, and the horse was placed as finished.



**Race 4** – Separate inquiries posted on unofficial third place finisher No. 2 EVERLASTINGFASHION (Mike Oosting) and unofficial fourth place finisher No. 5 SOUBRETTE (Jordan Ross) for possible pylon violations at different stages of the race. Video showed that No. 5 SOUBRETTE was inside of two consecutive pylons in the last turn before  $\frac{3}{4}$ . The judges determined that this did not give the horse an unfair advantage. Horse placed as finished. Mr. Ross fined \$100.00 for the pylon violation. Video showed that No. 2 EVERLASTING FASHION struck the last pylon before entering the passing lane but never went inside of it. No reason for placing and no fine to Mr. Oosting because he did not commit a violation.
