ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 – Inquiry posted on unofficial fourth place finisher No. 3 AMONG THE MISSING (Tyler Miller) for possible interference to No. 6 MISTER SHORTY (Jay Cross) around the far turn. While the video was tough to determine definitively what happened, driver Cross testified that his horse ducked in and when he went to make the correction that's what caused the horse to make a break. No violation and all horses placed as finished.

Race 2 – Inquiry posted on unofficial fourth place finisher No. 5 PARKLANE HILL (Patrizio Ancora) for possible interference to No. 6 GREAT IMAGE (Kyle Wilfong) while on a break after ¾. Driver Wilfong said that his horse was not interfered with, and he only steered out in anticipation of the breaking horse coming out into his path, which did not happen. No reason for disqualification and the horses were placed as finished.
