**** Brandon Bates suspended 30 days beginning September 1, 2023, for bringing a loaded firearm onto the backside in violation of Indiana Horse Racing Commission Rule 71 IAC 7-5-5. ****




Race 4 – No. 7 FOX VALLEY SAMPSON (John DeLong) originally finished eighth placed ninth for interference while on a break before $\frac{3}{4}$.

Race 4 – Mike Oosting, driver of No. 3 TOXIC ROCK, fined \$200.00 for causing welts to the horse.

Race 5 – Inquiry posted on unofficial fourth place finisher No. 1 NOBLESVILLE (Ronnie Wrenn, Jr.) for possible interference in the far turn. After reviewing video the judges determined that no interference occurred, and the horse was placed as finished.

Race 11 – Recall due to broken equipment on No. 5 KEEP SCORE.

Race 14 – Inquiry posted looking at an incident which occurred after $\frac{3}{4}$ entering the stretch. Replay showed that while on the lead No. 1 MY HOUSE (Ronnie Wrenn, Jr.) made a break and scattered the rest of the field. John DeLong, driver of No. 2 ROCKIE GOT FRAMED, went inside the pylons for safety reasons. While inside pylons the judges determined that Mr. DeLong did not urge his horse on and therefore did not gain an unfair advantage. No. 2 ROCKIE GOT FRAMED finished second and was not placed. No. 7 MY HOUSE finished seventh placed tenth.
