ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 – General inquiry posted looking at incident going to the half. The judges determined that while the pace slowed the horses did not get jammed up enough to warrant placing of any horses. No. 8 DO ME BETTER charted with broken equipment due to a flat tire caused by No. 3 MISS BANANA SPLEEF when that horse pulled.

No. 1 M'S MAGIC (Jordan Ross) originally finished eighth placed ninth for a pylon violation in the far turn.

Race 5 – Dan Shetler, driver of No. 2 FLYING IN THE WIND, asked about his actions in the stretch. Mr. Shetler said the horse got rough nearing the wire and he had to grab up.

Race 12 – General inquiry posted looking at whether No. 4 PRINCE HENRY made the fair start pole. Video showed the horse was inside the pole prior to the rest of the field being released and therefore was declared an official starter.
