PROPOSED FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER

On June 14, 2012, Complainant, Toni Harris ("Harris") obo Erin Davis ("Davis"), and Respondent – Papa John's International d/b/a Papa John's Pizza ("Papa John's") - filed their Joint Motion To Dismiss.

Having carefully considered the foregoing and being duly advised in the premises, the undersigned Administrative Law Judge for the Indiana Civil Rights Commission ("ICRC") proposes that the ICRC enter the following findings of fact, conclusions of law, and order.

FINDINGS OF FACT

- 1. This proceeding began when Harris filed a complaint with the ICRC on behalf of Davis alleging that Davis had been terminated from employment by Papa John's because of race and/or sex. COMPLAINT OF DISCRIMINATION (May 31, 2011).
- 2. Papa John's denies that claim. ANSWER (June 30, 2011).
- The Joint Motion is expressly motivated by settlement.

- 4. There is no evidence of fraud, coercion, duress, or any other reason not to approve of the requested dismissal.
- 5 Any Conclusion Of I aw that should have been deemed a Finding Of Fact is hereby adopted as such.

CONCLUSIONS OF LAW

- 1. The ICRC has jurisdiction over the subject matter and the parties.
- 2. Settlement is a favored resolution and should be encouraged.
- 3. Administrative review of this proposed decision may be obtained by the filing of a writing identifying with reasonable particularity each basis of each objection within 15 days after service of this proposed decision. IC 4-21.5-3-29(d).
- 4. Any Finding Of Fact that should have been deemed a Conclusion Of Law is hereby adopted as such.

ORDER

- 1. The Joint Motion To Dismiss is **GRANTED**.
- 2. The Status Conference that had been scheduled for July 30, 2012 is **CANCELLED**.
- 3. Davis's complaint is **DISMISSED**, with prejudice.
