3 CHAIRPERSON BLACKBURN: The Indiana  
4 Civil Rights Commission is now in public session.  
5 Lacking a quorum, there are but a few things that  
6 we can address in this session, and I will take  
7 those in the order that they are listed on the  
8 agenda.

9 We will hear the financial report.  
10 Ms. Joan Essex.

11 MS. ESSEX: Thank you.

12 I've prepared a financial report for you  
13 for the month ending May 31st, '08. Keep in mind  
14 that if there are any changes to the format of  
15 the financial statement that you would like to  
16 suggest that we make, I'm open to those  
17 suggestions. I've used the same format that  
18 you've been used to over the last few months, and  
19 any changes that you would like to have  
20 incorporated, just let me know.

21 We are in the process of ending our fiscal  
22 year. The last day to submit documents to the  
23 Auditor of State was last Friday, so they are

1 going through and putting finishing touches on  
2 running the last few documents through.

3 The next financial statement I hoped to be  
4 able to send out in your packet, but being the  
5 end of the fiscal year, it may be a preliminary  
6 year end, and I may bring a final year end at the  
7 meeting to give them time to close out  
8 sufficiently.

9 And that's all I have.

10 MS. MALONE: Madam Chair?

11 CHAIRPERSON BLACKBURN: Yes.

12 MS. MALONE: Could we just mark that  
13 the meeting started at 2:30 for the record?

14 CHAIRPERSON BLACKBURN: If we must.

15 (No response.)


16 CHAIRPERSON BLACKBURN: Hearing none,
