NOTICE OF PUBLIC HEARING

Preliminary Findings Regarding the Renewal of a Part 70 Operating Permit

for U.S. Steel Corporation - Gary Works in Lake County

No.: T089-46943-00121

The Indiana Department of Environmental Management (IDEM) has received an application from U.S. Steel Corporation - Gary Works located at One North Broadway, Gary, Indiana 46402 for a renewal of its Part 70 Operating Permit. IDEM's Office of Air Quality (OAQ) issues renewals of this type of permit to regulate the operation of existing sources and modifications at existing sources that release air pollutants.

The Office of Air Quality (OAQ) had a notice posted on IDEM's website (https://www.in.gov/idem/public-notices/) stating that the draft Part 70 Operating Permit Renewal for U.S. Steel Corporation - Gary Works had been proposed for this operation and provided information on how the public could review the proposed permit and other documentation. Due to several comments received by IDEM from interested parties, a public hearing will be held on April 25, 2024 to allow for testimony regarding the draft Renewal of a Part 70 Operating Permit for U.S. Steel Corporation - Gary Works.

You are invited to attend a public hearing regarding the U.S. Steel Corporation - Gary Works air permitting preliminary findings:

The Indiana Department of Environmental Management (IDEM) will hold a public hearing to allow for testimony regarding the draft Renewal of a Part 70 Operating Permit. IDEM, OAQ will hold this public hearing at the following time and location:

Thursday April 25, 2024, at 6:00 PM (CDT) 21st Century Charter School of Gary – Gymnasium 556 Washington St, Gary, Indiana 46402

What will happen at the hearing?

IDEM, OAQ will not provide responses to questions or comments made during the hearing. The purpose of the hearing is to allow for the public to provide testimony. IDEM will provide responses to all





comments made during the hearing, along with all other written comments provided to the agency during the public comment period, as part of the response to comment in the final permit desicion.

Written comments and supporting documentation can be submitted to IDEM before the end of the public notice period. The public notice period will end on Monday, April 29, 2024. All comments will be considered by IDEM when we make a decision to issue or deny the permit. Comments that are most likely to affect final permit decisions are those based on the rules and laws governing this permitting process (326 IAC 2), air quality issues, and technical issues. IDEM does not have legal authority to regulate zoning, odor or noise. For such issues, please contact your local officials. If you do not want to comment, but would like to be added to IDEM's mailing list to receive notice of future action related to this permit application, please contact IDEM. What will happen after IDEM makes a decision?

Following the end of the public comment period, IDEM will issue a Notice of Decision stating whether the permit has been issued or denied. If the permit is issued, it may be different than the draft permit because of comments that were received during the public comment period. If comments are received during the public notice period, the final decision will include a document that summarizes the comments and IDEM's response to those comments. If you have submitted comments or have asked to be added to the mailing list, you will receive a Notice of the Decision. The notice will provide details on how you may appeal IDEM's decision, if you disagree with that decision. The final decision will also be available on the Internet at the address indicated above and will also be sent to the local library indicated above, the IDEM Regional Office indicated above, and the IDEM public file room on the 12th floor of the Indiana Government Center North, 100 N. Senate Avenue, Indianapolis, Indiana 46204-2251.
