INDIANA DEPARTMENT OF
ENVIRONMENTAL MANAGEMENT

The Indiana Department of Environmental Management (IDEM) protects human health and the environment by implementing and enforcing environmental laws and rules, including those related to the handling, transport, storage, and disposal of waste tires, which are tires that no longer serve their original purpose.

Waste tire means a tire not suitable for the tire's original purpose.

Waste tire transporter means a person who engages in the business of:

- accepting waste tires; and
- transporting the waste tires to one or more locations.

HOW TO PROPERLY DISPOSE OF WASTE TIRES

Registered waste tire transporters must dispose of any tires that are in their possession by appropriate means set out in 329 IAC 15.

A registered waste tire transporter may take tires to one or more of these approved locations for proper disposal:

- A facility that retreads tires.
- A registered waste tire storage site.
- A registered waste tire processing operation.
- A permitted landfill.
- A tire wholesaler or to an agent of a wholesaler.
- A tire manufacturer.

Waste tire transporters are also required to prepare and carry a Waste Tire Manifest Form for each load of waste tires.

HOW TO APPLY FOR A WASTE TIRE TRANSPORTER REGISTRATION

To apply for an initial certificate of registration as a waste tire transporter, a person must submit a \$25 registration fee and a complete application (State Form 47220) to the Indiana Department of Environmental Management (IDEM) Office of Land Quality (OLQ) that contains the following:



- Transporter's contact information.
- A list of all the locations where the tires will be taken.
- A description of the tire transporting operations and quantities transported.
- A copy of all out of state registrations (if applicable).
- Evidence of at least ten thousand dollars (\$10,000) financial assurance, maintained in accordance with 329 IAC 15.

WASTE TIRE TRANSPORTER REQUIREMENTS

A person who acts as a waste tire transporter in Indiana shall pay an annual registration fee of twenty-five dollars (\$25).

Waste tire transporters are required to do the following:

- Prepare a waste tire manifest for each load and provide a copy to their customers.



- Keep a copy of a manifest for at least one year.
- Make a copy of a manifest available to IDEM upon request.
- Report annually to IDEM the number of passenger tires they transport.
- Maintain financial assurance.

ENFORCEMENT ACTION and PENALTIES

If a person engages in the business of accepting and transporting waste tires without a valid certificate of registration and proper financial assurance, the IDEM Commissioner may issue a Notice and Order containing the actions that must be taken to correct the violation[s] and requiring the payment of an appropriate civil penalty.
