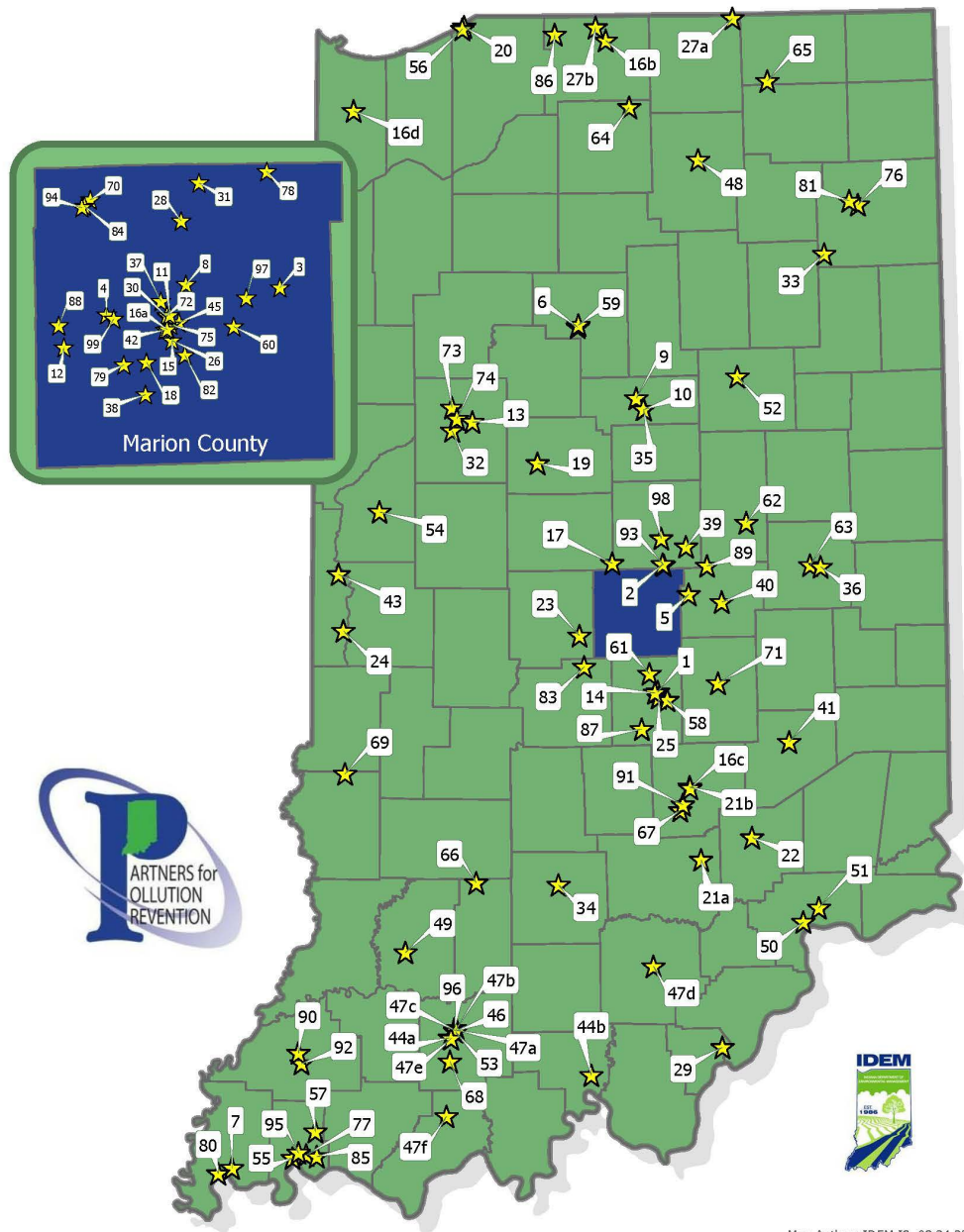
To Alan Resnik on his retirement

Why Change to Environmental Sustainability?

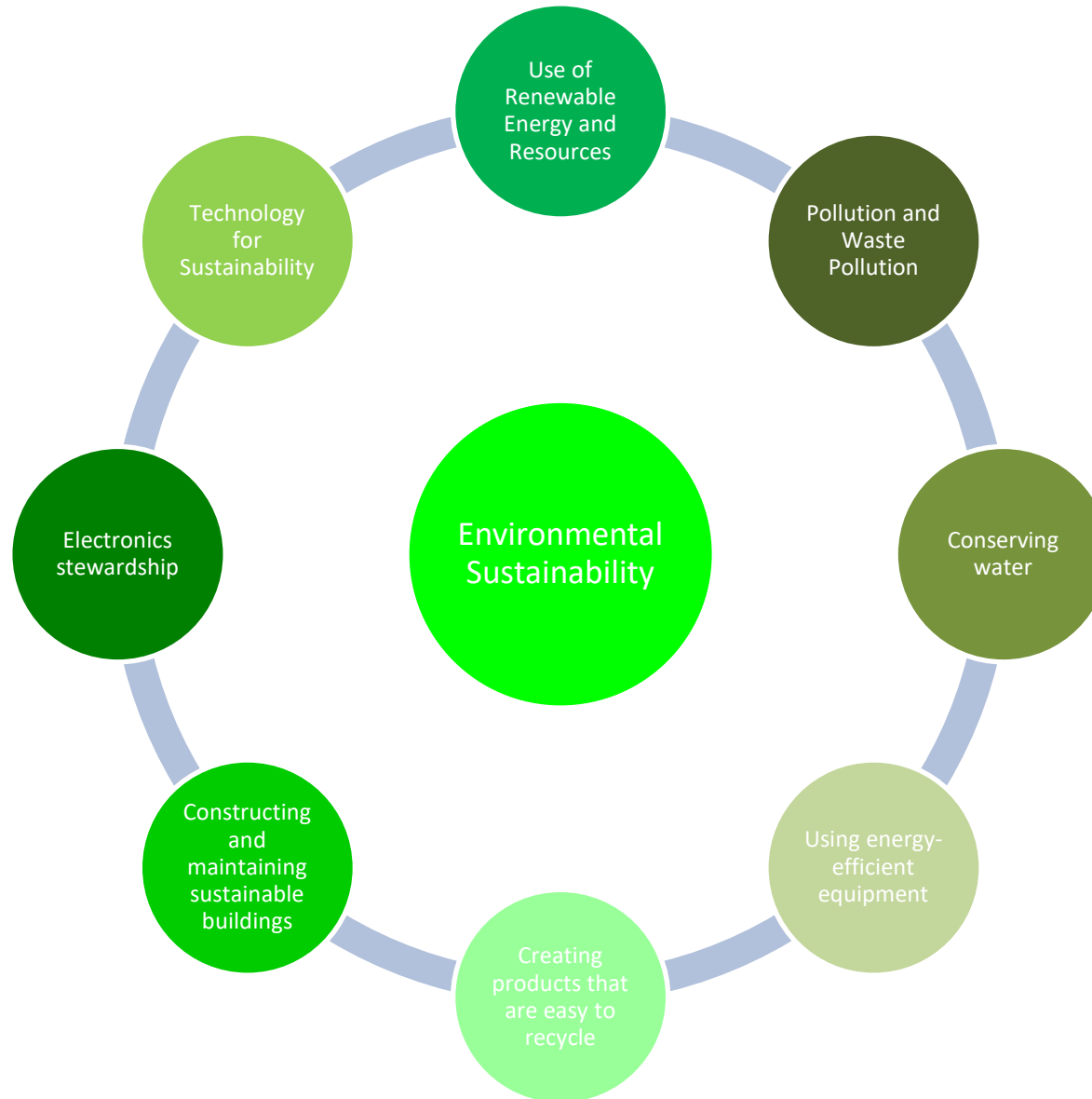
Pollution Prevention is STILL a cornerstone for Indiana Partners

Will aide in improving Indiana Environmental Sustainability

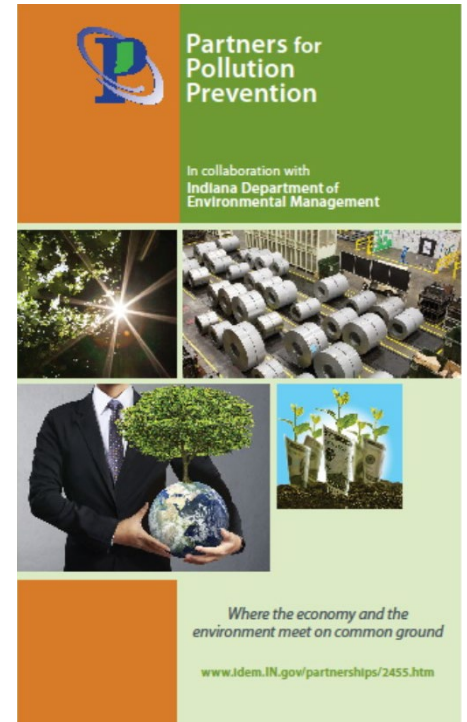
Increase more categories in initiatives to submit in APR and Awards
