Estimated Amount of two (2) year contract: \$654,734.81

Based on the State's evaluation of responses received for negotiated Bid 515-23-75291, Calderon Textiles, LLC is recommended for award to provide ICI for Boxers. Terms of the award recommendation are outlined in this letter.

During the course of evaluation, the State scrutinized all proposals to determine the viability of each proposed business solution to meet the needs of the State. The Indiana Department of Administration evaluated the proposal and awarded in accordance with the requirements set forth in the published process and pursuant to Indiana law.

Type of Award

The State intends to establish a contract for a period of two (2) years. The contract can be mutually renewed yearly for two additional years under the same terms and conditions.

Renewals are subject to the approval of the Department of Administration and the State Budget Agency. Total term of this agreement including all renewals, shall not exceed four years.
