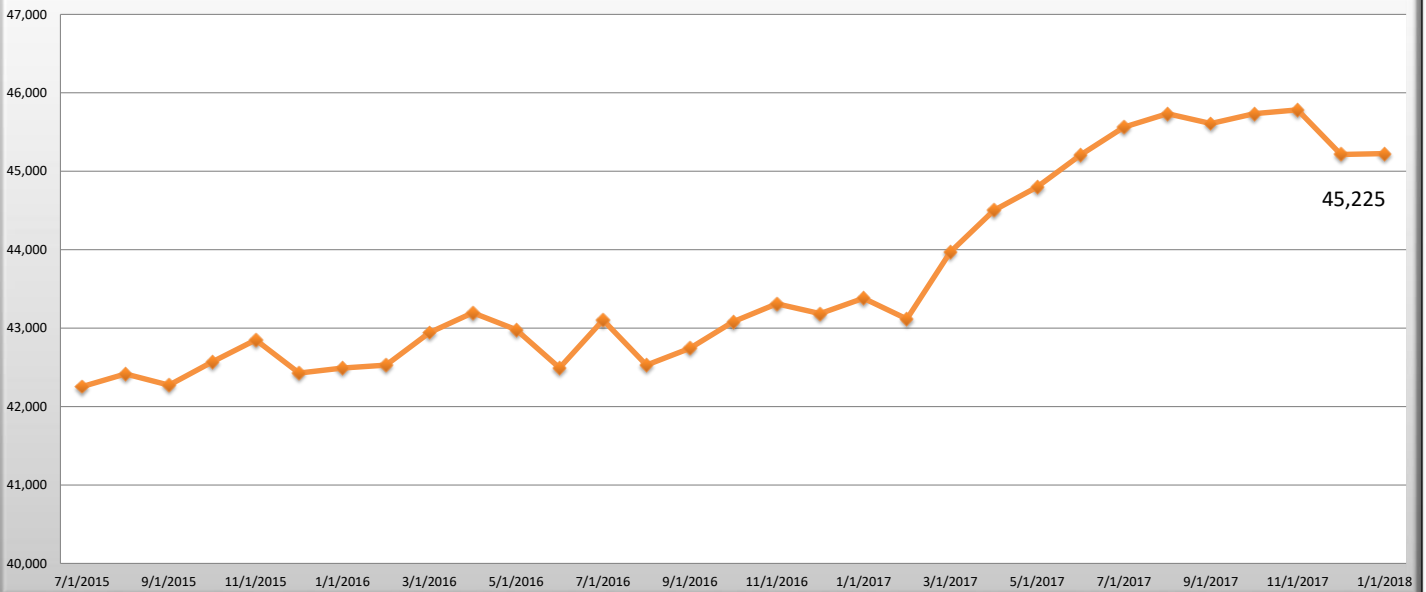

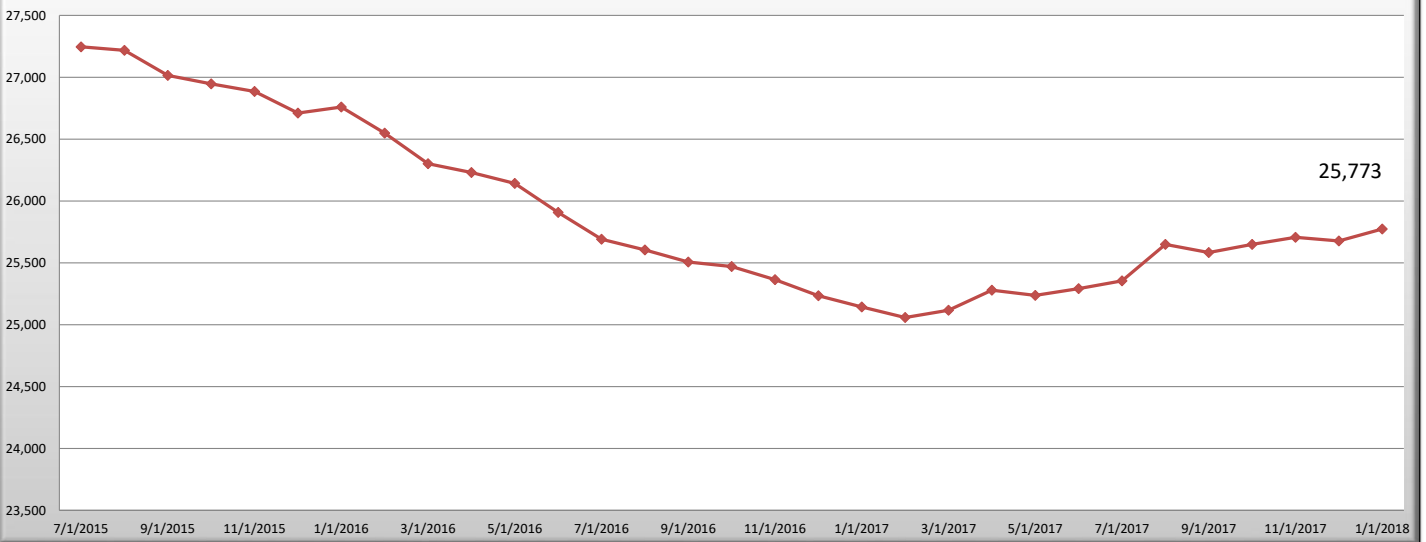

DOC Population Trend

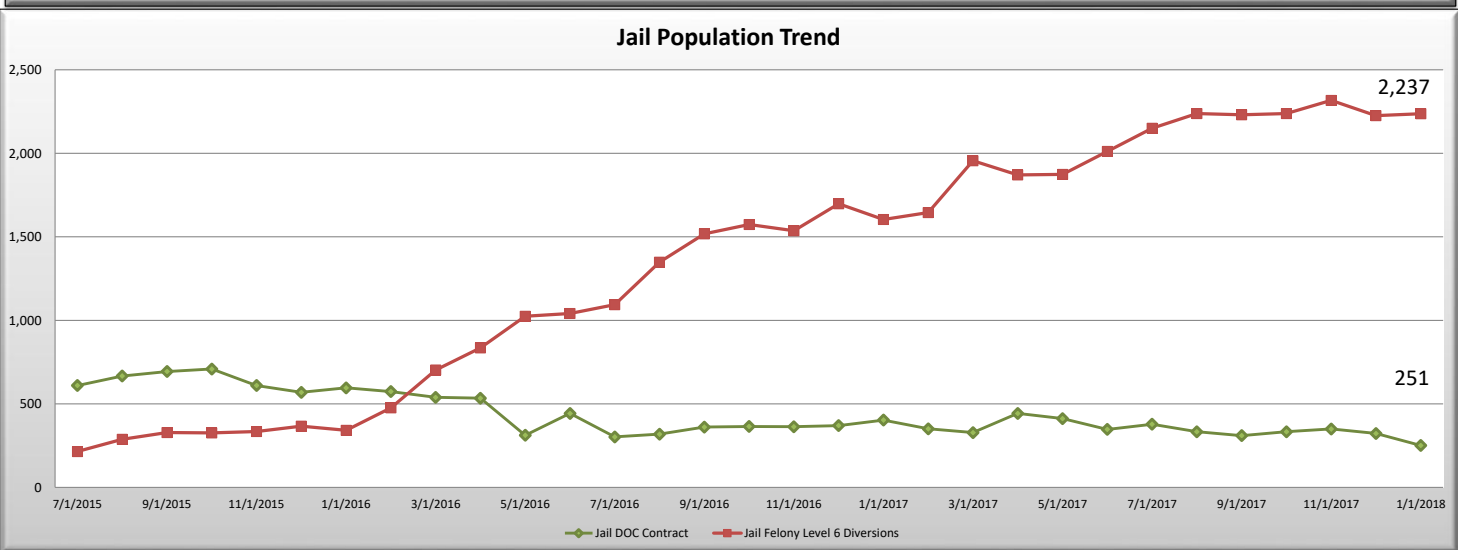
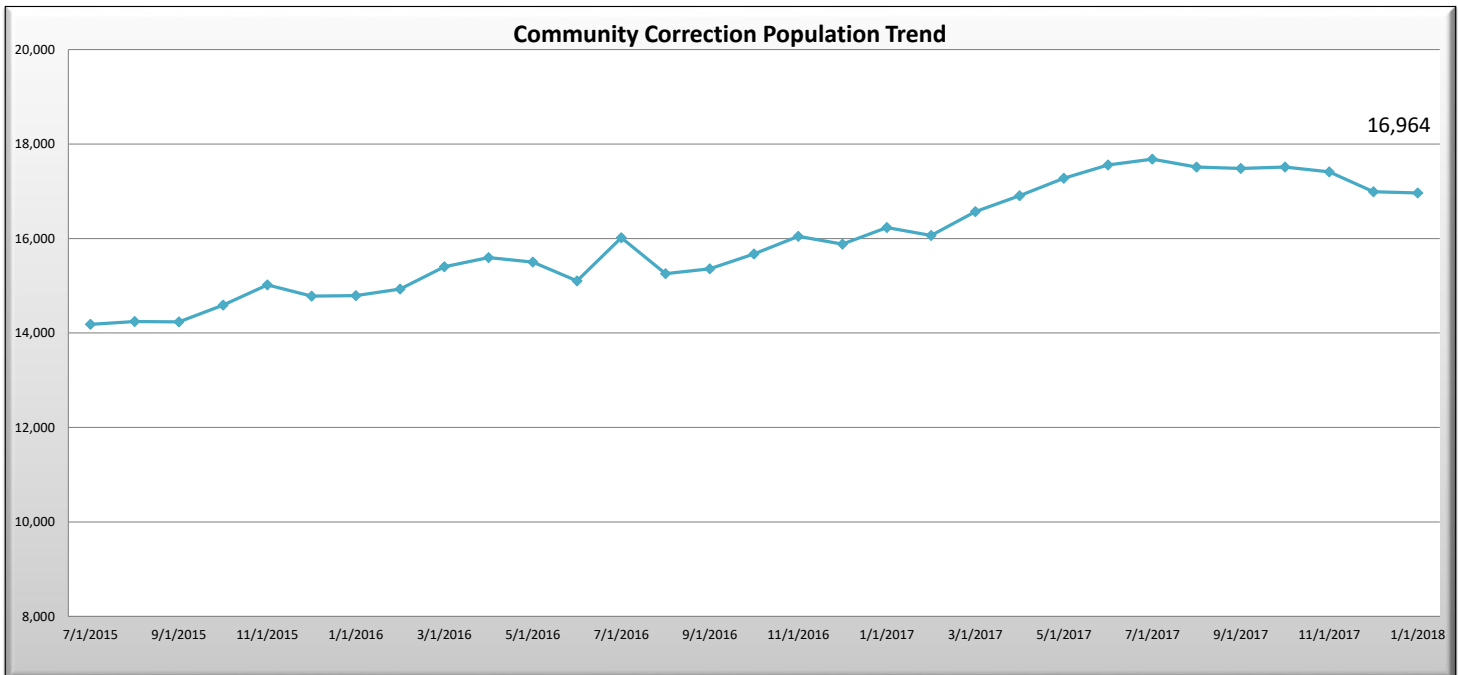
