Brownfield Assessment Grant Program

Brownfields Job Training and Development Demonstration Pilots

Targeted Brownfields Assessment (TBA)

This program provides technical assistance for environmental assessments at brownfield sites at no cost to municipalities, especially those without U.S. EPA Brownfields Assessment pilots/grants. TBAs supplement and work with other efforts under U.S. EPA's Brownfields Program.
