## Reminder: Indiana's Petroleum Remediation Grants Available Now

The time is now to come forward with sites in your community that are contaminated with petroleum products. The Indiana Brownfields Program has divided the state into seven regions for the purposes of administering the Petroleum Remediation Grant incentive in Indiana. \$750,000 has been set aside for each region for the assessment and remediation of petroleum-contaminated brownfield sites. Neither cash match nor investment from the community is required for this grant funding.

A consulting firm has been assigned to each region to work with Indiana Brownfields Program project managers to provide outreach to communities, compile information about potential sites, and perform the environmental assessment and remediation for the awarded sites. The consultants will submit an initial inventory of potential sites to the Indiana Brownfields Program by April 15, 2007. The first sites recommended for funding will then be presented to the Indiana Finance Authority Board of Directors for approval in June 2007. ## Updated SMARTe Now Available

Sustainable Management Approaches and Revitalization Tools - electronic (SMARTe) is a webbased, decision analysis support system for developing and evaluating future reuse scenarios for potentially contaminated land. SMARTe contains guidance and analysis tools for addressing all aspects of the revitalization process. A few of the new features in the January 2007 version of SMARTe include:

- \* New Getting Started section to help users who are just beginning a revitalization project
- \* Updated content on environmental, social, and economic resources
- \* New checklists including how to select a developer and environmental lawyer
- \* New case studies
- \* Expanded list of links to additional resources
