Technical Assistance to Brownfields (TAB) **s**ervices for U.S. Environmental Protection Agency (EPA) Region 5 states (including Indiana), formally provided by Purdue University, are now being offered by the Center for Hazardous Substances Research (CHSR) at Kansas State University. Program Update:

State of Indiana Seeking Public Comment for its Federal Brownfield Grant Proposals

The State of Indiana is in the process of applying to the U.S. Environmental Protection Agency for two grants to facilitate brownfield redevelopment in Indiana communities. One grant proposal is to capitalize a Revolving Loan Fund (RLF) for the cleanup of brownfield sites throughout Indiana. The Indiana Finance Authority will partner with a coalition of regional planning and development commissions and other entities for the purpose of this grant. The RLF will provide *zero-interest* loans and subgrants for the cleanup of eligible brownfield sites.

The other grant proposal is for the Indiana Department of Environmental Management to establish the Indiana Brownfields Trails and Parks Initiative. This initiative will offer environmental site assessments for eligible political subdivisions and non-profit entities for the purpose of developing trails and parks on brownfields throughout Indiana, with a special focus on railsto-trails projects.

The Indiana Brownfields Program seeks public comment regarding these proposals. Please visit the Indiana Brownfields Program's Web site to view the draft proposals. Brownfields Nuts and Bolts Training Coming Soon to Indianapolis

The Nuts and Bolts of Brownfield Redevelopment for Local Governments training course, conducted in cooperation with U.S. EPA, will be held in Indianapolis in the late summer or early fall of 2007. Those who have been fortunate enough to attend a Nuts and Bolts course in the past have expressed that it is an excellent opportunity to learn about the particulars of brownfield redevelopment. It is a very thorough 3-day course that covers topics such as brownfield site identification strategies, economics of brownfields redevelopment, environmental insurance, risk assessment, and sustainable redevelopment, just to name a few. Case studies, interactive exercises, and trips to area brownfield sites are also incorporated into the course. Time is Running Out to Take Advantage of the Voluntary Remediation Tax Credit

The Voluntary Remediation Tax Credit (VRTC) was established by the Indiana General Assembly in 2001 to reward eligible taxpayers who conduct voluntary remediation activities at brownfield sites. Site Highlight: Ground Breaking Ceremony Marks a New Beginning for Scribner Place in New Albany

A ground breaking ceremony for the Scribner Place project was held on November 6, 2006. The 6.5-acre Scribner Place property, located along the Ohio River in New Albany, has been an eyesore for decades. The site consists of eight contiguous parcels that extend along Main Street and is currently owned by the City. Former operations as far back as the 1800s include machine shops, foundries, coal yards, automotive service stations, boiler manufacturers, and warehouses.

Thanks in part to a variety of public and private assistance at the local, state, and federal levels, this property will no longer be an eyesore. The City is well underway with plans for a \$23 million redevelopment of a 3-acre portion of the site into a YMCA and Aquatic Center. This redevelopment is primarily funded by a \$20 million grant from the Caesar's Riverboat Foundation of Floyd County, YMCA funds, as well as local revenues from the City of New Albany and Floyd County.

Assessment and cleanup of the contamination on this part of the site were completed with oversight from the Indiana Brownfields Program, and the City has received an Indiana Department of Environmental Management Site Status Letter for the project indicating that no further response actions are necessary on this portion of the site and that the site can be redeveloped as planned.

The environmental work for the project was funded by several sources. The site, which had been contaminated with heavy metals, polyaromatic hydrocarbons, and volatile organic compounds, was assessed, in part, using approximately \$39,000 in state brownfield grants and matching local funds, and was remediated using \$400,000 in cleanup grants from the U.S. EPA Brownfields Program. This redevelopment project is a great example of leveraging state, federal, local, and private funding to bring a downtown revitalization project to successful completion. It was recognized as such at the 2006 National Brownfields Conference in Boston this month. The project was one of six that received certificates of appreciation from U.S. EPA Region 5 Administrator Mary Gade at the conference.
