**Call to Order and Roll Call:**

Chairman Cris Johnston called the meeting to order at 1:00 p.m. local time. A quorum was present.

**Approval of the Minutes:**

Upon motion by Joseph Svetanoff, second by Marc Fine, and unanimous vote of those present, the Commission approved the proposed minutes from the November 12, 2015, Business Meeting.

**Report of the Executive Director:**

The Executive Director began her report welcoming the newest employees, Noah Jackson as the new Staff Attorney, Kimi Simpson as the new Program Coordinator in Charity Gaming, Barry Arnett as a new Background Investigator, and Patrick Rhodes as the new Director of License Control. Hannah Rose transferred from Licensing Coordinator to Executive Administrative Assistant, Dan Lee transferred from Gaming Agent to Investigator in the North Zone, Nick Rentas transferred from Gaming Agent to Supervisor at Blue Chip Casino, and Tami Timberman-Wright transferred from VEP Coordinator to Licensing Coordinator.

**Staff Presentation:**

General Counsel, Greg Small, provided the Commissioners with an update regarding the ongoing dispute between the City of Lawrenceburg, the Lawrenceburg Conservancy District, and Hollywood Casino.

**Waiver of Rules and Regulations:**

**Ameristar & Belterra:** Both casinos were allowed the use of an RFID table and cards for the final table at the Heartland Poker Tournament. Prior to play, local IGC and Casino Operations will inspect the cards to ensure they meet the Commission's requirements. 68 IAC 2-2-1(c)(2)(c) and 68 IAC 2-7-2(a).

**Belterra:** Granted a onetime waiver from the requirement of a vendor badge due to safety concerns. 68 IAC 15-6-2(10) and 68 IAC 15-6-4(d).

Allowed to, while hosting the Heartland Poker Tournament, utilize vendor badges through security dispatch, so long as they: provide information regarding the list of the traveling team to local IGC in advance and the traveling dealers utilizing vendor badges in lieu of licensing procedures will not handle any cash/value chips, will not deal any cash games, and are simply on property to deal at the Heartland Poker Tournament.

**French Lick:** Granted relief from the requirement to submit the list of currency collection and soft count employees to the Agents. 68 IAC 11-3-2(a).

Allowed to give a two day notice for the EGDs being moved between the Annex warehouse and the casino warehouse. 68 IAC 17-1-2(a).

Allowed to perform weekly progressive audits. 68 IAC 12-1-5(f)(6)(B).

**Horseshoe Southern Indiana:** Granted relief from the requirement to install two locks on the compartment door where a progressive controller is stored. 68 IAC 2-6-40(a) and (b).

**Horseshoe Hammond and Horseshoe Southern Indiana:** The Commission previously granted a waiver that allowed them to forgo the maintenance of found cash equivalents valued at \$5 or less. Since the relief of this requirement, the casinos have had no issues or complaints, so they have been granted relief to \$10 or less.

**Majestic Star:** Allowed to store their secondary set of chips in a caged storage cabinet in the count room, with the ability to perform physical inventories of these chips only when the audit seal has been broken or tampered with. Additionally, the casino will be allowed to perform physical inventories of the primary reserve chips annually, as these chips are also stored in a caged storage cabinet in the coin vault with an audit seal. All current security measures would continue to be maintained. 68 IAC 15-4-3(5).




