

RESOLUTION 1995- 11

**A RESOLUTION CONCERNING AN EXTENSION OF THE
CERTIFICATES OF SUITABILITY ISSUED TO TRUMP
HOTELS AND CASINO RESORTS AND BARDEN/PRESIDENT RIVERBOAT
CASINO-GARY, LLC ON DECEMBER 9, 1994**

WHEREAS, the Indiana Gaming Commission, ("the Commission") has the power and duty under IC 4-33-4-1 to fully and effectively execute IC 4-33 ("the Riverboat Gambling Law");

WHEREAS, the Commission has the power and duty to take any reasonable or appropriate action to enforce the Riverboat Gambling Law;

WHEREAS, the Commission is required under IC 4-33-4-5 to adopt standards for the licensing of persons regulated under the Riverboat Gambling Law;

WHEREAS, pursuant to IC 4-33-4-17, the Commission is to "decide promptly and in reasonable order all license applications"; and

WHEREAS, on December 9, 1994, the Commission issued Certificates of Suitability to Trump Hotels and Casino Resorts and Barden/President Riverboat Casino-Gary LLC; each Certificate of Suitability being valid for a period of one hundred eighty (180) days;

WHEREAS, each Certificate of Suitability will expire on or about June 7, 1995;

WHEREAS, both Trump Hotels and Casino Resorts and Barden/President Riverboat Casino-Gary, LLC have requested a hearing as to the extension of each of the respective Certificates of Suitability (copies of letters attached);

WHEREAS, the present schedule of the Commission is such that meaningful hearings as to the extension of each of the Certificates of Suitability cannot be had until after June, 1995; and

WHEREAS, both Trump Hotels and Casino Resorts and Barden/President Riverboat Casino have, independently and together, made progress toward complying with the conditions set forth in the Certificate of Suitability.

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC 1-1 apply to this resolution.

SECTION 2. EXTENSION OF CERTIFICATES OF SUITABILITY ISSUED TO TRUMP HOTELS AND CASINO RESORTS AND BARDEN/PRESIDENT RIVERBOAT CASINO-GARY, LLC.

The Certificates of Suitability issued to Trump Hotels and Casino Resorts and Barden/President Riverboat Casino-Gary, LLC are each extended, and will be remain valid, until July 31, 1995.

SECTION 3. EFFECTIVE DATE.

This resolution is effective immediately.


