

RESOLUTION 1998-17

A RESOLUTION CONCERNING AN EXTENSION OF THE CERTIFICATE OF SUITABILITY ISSUED TO RDI/CAESARS RIVERBOAT CASINO, L.L.C. ON MAY 20, 1996

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The following factors have been considered by the Commission:

1. The Commission issued a Certificate of Suitability to RDI/Caesars Riverboat Casino, L.L.C. on May 20, 1996. The Certificate of Suitability was valid for a period of one hundred eighty (180) days.
2. The Commission issued an extension of the Certificate of Suitability to RDI/Caesars Riverboat Casino, L.L.C. on November 13, 1996, December 17, 1996, July 22, 1997, October 22, 1997, and March 17, 1998. The March 17, 1998 extension of the Certificate of Suitability is to expire at the time the Commission members hold a business meeting pursuant to 68 IAC 1-2-5 during which the Commission members will be able to conduct a hearing on this matter.
3. On February 27, 1998 RDI/Caesars Riverboat Casino, L.L.C. requested an extension of the Certificate of Suitability (copy of letter attached to Resolution 1998-11).
4. The Commission has heard from RDI/Caesars, Riverboat Casino, L.L.C., and has reviewed the documentation submitted.
5. The Commission has heard from those parties in opposition to the extension of the Certificate of Suitability and who filed a written request to address the Commission.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING
COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

SECTION 1. SCOPE.

This resolution applies to RDI/Caesars Riverboat Casino, L.L.C.

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. EXTENSION OF CERTIFICATE OF SUITABILITY ISSUED TO RDI/CAESARS RIVERBOAT CASINO, L.L.C.

The Certificate of Suitability issued to RDI/Caesars Riverboat Casino, L.L.C. is hereby:
