

## **RESOLUTION 1999-1**

### **A RESOLUTION CONCERNING THE ISSUANCE OF PERMANENT OCCUPATIONAL LICENSES**

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The following factors have been considered by the Commission:

1. In accordance with IC 4-33-8 and 68 IAC 2-3, suitable applicants for an Occupational License are issued a temporary Occupational License pending the completion of a background investigation.
2. Temporary Occupational Licenses were issued to applicants for employment with Aztar Indiana Gaming Corporation ("Aztar") beginning November 20, 1995 and Majestic Star Casino and Trump Indiana ("Trump") beginning May 6, 1996.
3. The Commission has completed background checks on the temporary Occupational Licensees employed at Aztar, Majestic Star and Trump. The background investigation conducted by the Indiana State Police, Gaming Enforcement Section has indicated that the individuals set forth on the attached lists meets the criteria set forth in IC 4-33 and 68 IAC for licensure.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

#### **SECTION 1. SCOPE.**

This resolution applies to all individuals set forth on the attached who applied for a Permanent Occupational License to work for Aztar, Majestic Star and Trump.

#### **SECTION 2. DEFINITIONS.**

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

**SECTION 3. GRANT OF PERMANENT OCCUPATIONAL LICENSE FOR QUALIFIED INDIVIDUALS.**

The Commission hereby grants permanent Occupational Licenses to the individuals set forth on the attached lists to work for Aztar, Majestic Star and Trump. The permanent Occupational Licenses will be valid for a period of one (1) year from the date badges are issued to these individuals by the Commission.

**SECTION 4. CONDITIONS PLACED ON OCCUPATIONAL LICENSES.**

- A. Issuance of the permanent Occupational Licenses is conditioned upon payment of the appropriate licensure fee by the Casinos. Failure to remit payment may result in the revocation of any of the Occupational Licenses.
- B. Aztar, Majestic Star and Trump or the Occupational Licensee must request renewal of the Occupational License at least thirty (30) days before the expiration of the Occupational License in accordance with 68 IAC 2-3-8.

**SECTION 5. EFFECTIVE DATE.**

This RESOLUTION is effective immediately.
