

RESOLUTION 2000-15

**A RESOLUTION ADOPTING AS FINAL RULES
68 IAC 6-2; 68 IAC 15-11-3; 68 IAC 15-11-3.1; 68 IAC 15-12-3;
68 IAC 15-12-4; 68 IAC 15-13-2; AND 68 IAC 19-1**

The Indiana Gaming Commission (“Commission”) adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The Commission has considered the following factors:

1. The Commission has begun promulgation of these rules pursuant to IC 4-21.5, and these rules were published in the *Indiana Register* on August 1, 1999.
2. A hearing on these rules was held on August 25, 1999. All written comments received regarding these rules have been provided to the Commission members for review. There were no oral comments made at the hearing.
3. The promulgation process for the final promulgation of these rules will take approximately four (4) to six (6) months.

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1. SCOPE.

This resolution applies to each applicant, each licensee, each riverboat license applicant, any person who does business with an applicant or licensee, and any person who is a patron of a Riverboat Gambling Operation.

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. ADOPTION OF THE FINAL RULES.

The Commission adopts the following final rules pending completion of the promulgation process:

Pursuant to IC 4-22-2-27 through IC 4-22-2-30, the Commission adopts the rules, which will be forwarded to the Attorney General's Office for approval as final rules pursuant to IC 4-22-2-32. Upon approval by the Attorney General's Office, the rules will be submitted to the Governor's office for approval pursuant to IC 4-22-2-33. After the rules have been approved or deemed approved by the Governor, the rules will be submitted to the Secretary of State for filing in accordance with IC 4-22-2-35. The Commission further adopts any stylistic, grammatical, typographical, or other nonsubstantive changes that the Commission, the Attorney General's Office, or the Legislative Services Agency may make before the rules are printed as final rules in the *Indiana Register*.

SECTION 4. EFFECTIVE DATE.

This RESOLUTION is effective immediately.

SECTION 5. EXPIRATION DATE.

This RESOLUTION expires thirty (30) days from the date and time that the Secretary of State accepts the rules listed in Section 3 for filing.
