

RESOLUTION 2001-21

A RESOLUTION CONCERNING THE RENEWAL OF SUPPLIERS' LICENSES

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The following factors have been considered by the Commission:

1. On June 12, 1998, by RESOLUTION 1998-19, a Supplier's License was issued to Casino Data Systems, Sigma Game, Inc. and Shuffle Master, Inc.
2. On May 14, 1999, by RESOLUTION 1999-14 and May 12, 2000, by RESOLUTION 2000-17, Casino Data Systems, Sigma Game, Inc. and Shuffle Master, Inc. were granted the Renewal of their Supplier's License.
4. In accordance with IC 4-33-7-8 and 68 IAC 2-2-8, a Supplier's License must be renewed annually.
5. The above named supplier licensees have requested a renewal of the Supplier's License and the renewal will be conditioned upon payment of the renewal fee in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8, in addition to any outstanding background investigative fees. If payments of the renewal fee and background investigation fees are not received as directed by the Commission staff, the license will not be renewed.
6. The Commission has determined that the above named supplier licensees remain in compliance with IC 4-33.

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1. SCOPE.

This resolution applies to the supplier licensees listed above in paragraph one.

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. GRANT OF RENEWAL OF SUPPLIERS' LICENSES.

The Commission hereby grants the renewal of the Suppliers' Licenses issued to the suppliers listed below on condition that renewal fee and any background investigative fees are paid as directed by the Commission staff. The renewed suppliers' licenses will be valid for a period of one (1) year from the date of issuance.

SECTION 4. CONDITIONS PLACED ON SUPPLIER'S LICENSE.


- A. The supplier licensees must request renewal of the supplier's license at least thirty (30) days before the expiration of the license in accordance with 68 IAC 2-2-8.

SECTION 5. EFFECTIVE DATE.

This RESOLUTION is effective immediately.
