

## **RESOLUTION 2002-16**

### **A RESOLUTION CONCERNING THE REQUEST FOR APPROVAL OF FLEXIBLE SCHEDULING BY THE RIVERBOAT LICENSED OWNERS**

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The following factors have been considered by the Commission:

1. Pursuant to Indiana Code 4-33-6-21, the Commission affirms the time and date set by the Commission staff as close of business, July 12, 2002, as the deadline for all riverboats to submit a plan for flexible scheduling.
2. All ten (10) Indiana riverboats submitted a plan for flexible scheduling by close of business, July 12, 2002.
3. The Commission has reviewed the plans submitted and finds each plan appropriate.
4. The Commission shall authorize flexible scheduling and the riverboat licensed owners with the exception of Showboat Marina Casino Partnership, known as Harrah's East Chicago Casino, Majestic Star Casino, LLC and Trump Indiana, Inc. shall implement the appropriate flexible scheduling plans on the gaming day commencing 6:00 a.m., August 1, 2002. **NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

#### **SECTION 1. SCOPE.**

This resolution applies to the Indiana riverboat licensed owners.

#### **SECTION 2. DEFINITIONS.**

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

**SECTION 3. ACTION ON REQUEST FOR APPROVAL OF FLEXIBLE SCHEDULING BY THE RIVERBOAT LICENSED OWNERS.**

The request for approval of flexible scheduling by the riverboat licensed owners is hereby:
