

## **RESOLUTION 2003-28**

### **A RESOLUTION CONCERNING THE RENEWAL OF SUPPLIERS' LICENSES**

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The Commission has considered the following factors:

1. On May 13, 2002, by RESOLUTION 2002-10, a Supplier's License was issued to **ServiceMaster by Wallace, Inc.**
2. On May 13, 2002, by RESOLUTION 2002-11, the Commission renewed the Suppliers' Licenses held by Konami Gaming, Inc. and Hasgoe Cleaning Systems, Inc.
3. On July 29, 2002, by RESOLUTION 2002-19, the Commission renewed the Suppliers' Licenses held by Casino Data Systems, Shuffle Master, Inc., GEMACO Playing Card Company, Osborne Coinage Company, Paul-Son Gaming Supplies, Inc., Atronic Americas, LLC and Kilmartin Industries, Inc., d/b/a-Roger Williams Mint.
4. In accordance with IC 4-33-7-8 and 68 IAC 2-2-8, a Supplier's License must be renewed annually.
5. The above-named Supplier Licensees have requested a renewal of licensure and the renewal fees have been paid in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8. The Supplier Licensees may have outstanding background investigation fees and will be responsible for payment of the background fees. If payment for the background fees is not received as directed by the Commission staff, the license will be subject to non-renewal or revocation.
6. The Commission has determined that the above-named Supplier Licensees remain in compliance with IC 4-33.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

#### **SECTION 1. SCOPE.**

This resolution applies to the Supplier Licensees listed above in paragraphs one, two and three.

**SECTION 2. DEFINITIONS.**

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

**SECTION 3. GRANT OF RENEWAL OF SUPPLIERS' LICENSES.**

The Commission hereby grants the renewal of the Suppliers' Licenses issued to the suppliers listed below on the condition that any outstanding background fees are paid as directed by the Commission staff. The renewed Suppliers' Licenses will be valid for a period of one (1) year from the date of issuance.

**SECTION 4. CONDITIONS PLACED ON EACH SUPPLIER'S LICENSE.**


The Supplier Licensees must request renewal of the Supplier's License at least thirty (30) days before the expiration of the license and pay the renewal fee in accordance with 68 IAC 2-2-3 (c) and 68 IAC 2-2-8.

**SECTION 5. EFFECTIVE DATE.**

This RESOLUTION is effective immediately.
