

## RESOLUTION 2006-82

### A RESOLUTION ADOPTING LSA DOCUMENT #06-191 AS A FINAL RULE

The Indiana Gaming Commission (“Commission”) adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The Commission has considered the following factors:

1. The Commission has begun promulgation of the attached LSA Rule Document #06-191 under IC 4-22. A Notice of Intent to adopt LSA Document #06-191 was posted at DIN 20060705-IR-068060191NIA on the *Indiana Register* website on July 5, 2006. The rule was then posted at DIN 20060823-IR-068060191PRA on the *Indiana Register* website on August 23, 2006.
2. The Commission held a public hearing on this rule on September 20, 2006 at 2:00 p.m. in compliance with IC 4-22. The transcript of the hearing and all written comments that were received, fully considered, and implemented where appropriate. The transcript of the hearing and all written comments have been reviewed by Commission members.
3. If the Commission approves this Resolution adopting the attached rule document as a final rule, the rule will be forwarded to the Office of the Attorney General and the Governor for approval, and filed thereafter with the *Indiana Register*. The rule will be effective 30 days after it is filed with the *Indiana Register*.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

#### SECTION 1: SCOPE

This resolution applies to all persons and entities licensed by the Commission, all persons or entities that have applied to the Commission for licensure, all operating agents or operating agent applicants, any person who does business with a licensee, license applicant, operating agent, or operating agent applicant and any person who is a patron of a Riverboat Gambling Operation.

#### SECTION 2: DEFINITIONS

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

#### SECTION 3: ADOPTION OF FINAL RULES
