

**ORDER 2010-06**  
**AN ORDER OF THE INDIANA GAMING COMMISSION**  
**CONCERNING THE VOLUNTARY EXCLUSION PROGRAM**  
**CASE NO. VEP-10-05**

On or about March 12, 2005, John Doe #5 submitted an application to the Indiana Gaming Commission ("Commission") to participate in the Voluntary Exclusion Program for a minimum of one year. Pursuant to 68 IAC 6-3-2(d), if a patron does not request removal from the program after the expiration of the program term, he or she remains validly in the program. Pursuant to 68 IAC 6-3-2(g), a participant in the program agrees that if he or she violates the terms of the program and enters the gaming area of a facility under the jurisdiction of the Commission he or she willingly forfeits any money or thing of value obtained from or owed to the participant by a casino. The casino must withhold forfeited monies or things of value and remit them to the Commission, which collects the funds.

On or about February 9, 2010, John Doe #5 was discovered to be present at Ameristar Casino ("Ameristar"). At that time, John Doe #5 had not requested removal from the program. At that time, John Doe #5 had obtained \$3,500.00 in chips from Ameristar. Ameristar withheld the monies as required by Commission regulations and seeks Commission approval for remittance, less applicable taxes on the winnings, in fulfillment of John Doe #5's voluntary exclusion application.

The Commission, after reviewing this matter:


APPROVES

the remittance of \$3,500.00, less applicable taxes, in fulfillment of John Doe #5's voluntary exclusion application.
