

ORDER 2010-12
AN ORDER OF THE INDIANA GAMING COMMISSION
CONCERNING THE VOLUNTARY EXCLUSION PROGRAM
CASE NO. VEP-10-11

On or about September 3, 2008, John Doe #11 submitted an application to the Indiana Gaming Commission ("Commission") to participate in the Voluntary Exclusion Program for a minimum of five years. Pursuant to 68 IAC 6-3-2(g), a participant in the program agrees that if he or she violates the terms of the program and enters the gaming area of a facility under the jurisdiction of the Commission he or she willingly forfeits any money or thing of value obtained from or owed to the participant by a casino. The casino must withhold forfeited monies or things of value and remit them to the Commission, which collects the funds.

On or about October 20, 2009, John Doe #11 was discovered to be present at Grand Victoria Casino ("Grand Victoria"). At that time, John Doe #11 had obtained \$343.00 in chips from Grand Victoria. Grand Victoria withheld the monies as required by Commission regulations and seeks Commission approval for remittance, less applicable taxes on the winnings, in fulfillment of John Doe #11's voluntary exclusion application.

The Commission, after reviewing this matter:

APPROVES

the remittance of \$343.00, less applicable taxes, in fulfillment of John Doe #11's voluntary exclusion application.

Pursuant to IC 4-21.5-3-5, this ORDER becomes effective 15 days following receipt of the Order of the Indiana Gaming Commission.
