

ORDER 2010-81
AN ORDER OF THE INDIANA GAMING COMMISSION
CONCERNING THE VOLUNTARY EXCLUSION PROGRAM
CASE NO. VEP-10-47

On or about June 30, 2005, John Doe #47 submitted an application to the Indiana Gaming Commission ("Commission") to participate in the Voluntary Exclusion Program for lifetime exclusion. Pursuant to 68 IAC 6-3-2(g), a participant in the program agrees that if he or she violates the terms of the program and enters the gaming area of a facility under the jurisdiction of the Commission he or she willingly forfeits any money or thing of value obtained from or owed to the participant by a casino. The casino must withhold forfeited monies or things of value and remit them to the Commission, which collects the funds.

On or about February 11, 2010, John Doe #47 was discovered to be present at Hollywood Casino ("Hollywood"). At that time, John Doe #47 had obtained \$61.00 in cash equivalents from Hollywood. Hollywood withheld the monies as required by Commission regulations and seeks Commission approval for remittance, less applicable taxes on the winnings, in fulfillment of John Doe #47's voluntary exclusion application.

The Commission, after reviewing this matter:

APPROVES

the remittance of \$61.00, less applicable taxes, in fulfillment of John Doe #47's voluntary exclusion application.

Pursuant to IC 4-21.5-3-5, this ORDER becomes effective 15 days following receipt of the Order of the Indiana Gaming Commission.
