

ORDER 2017-34
AN ORDER OF THE INDIANA GAMING COMMISSION
CONCERNING THE RENEWAL OF SUPPLIERS' LICENSES

In accordance with Ind. Code art. 4-33, Ind. Code art. 4-35, and 68 IAC 2-2, the Indiana Gaming Commission ("Commission") previously issued permanent suppliers' licenses to: (1) Bally Gaming, Inc., (2) Data Financial, Inc., (3) SUZOHAPP Gaming Solutions, Inc. f/k/a Happ Controls, Inc., (4) IGT, (5) Incredible Technologies, Inc., (6) Interblock Luxury Gaming Products, d.d., (7) Midwest Game Supply Co., (8) Technical Security Integration, Inc., (9) Halifax Security, Inc. (d/b/a North American Video), (10) Zuvid, LLC, (11) Patriot Gaming & Electronics, Inc., and (12) TCS John Huxley Europe, Ltd.

A supplier's license is valid for a period of one year. In accordance with Ind. Code § 4-33-7-8, a supplier's license must be renewed annually along with the payment of \$7,500 as an annual renewal fee. Each of these licensees requested renewal of its license and paid the renewal fee. The Commission has determined that the above-named supplier licensees remain in substantial compliance with Ind. Code art. 4-33 and are suitable to hold a supplier's license.

The Commission hereby **GRANTS** renewal of the licenses of each of the suppliers for a period of one year as specified below:

- 1) Bally Gaming, Inc.: valid March 30, 2017 through March 29, 2018;
- 2) Data Financial, Inc.: valid March 4, 2017 through March 3, 2018;
- 3) SUZOHAPP Gaming Solutions, Inc.: valid March 20, 2017 through March 19, 2018;
- 4) IGT: valid January 26, 2017 through January 25, 2018;
- 5) Incredible Technologies, Inc.: valid March 4, 2017 through March 3, 2018;
- 6) Interblock Luxury Gaming Products, d.d.: valid March 19, 2017 through March 18, 2018;
- 7) Midwest Game Supply Co.: valid March 27, 2017 through March 26, 2018
- 8) Technical Security Integration, Inc.: valid March 17, 2017 through March 16, 2018;
- 9) Halifax Security, Inc.: valid February 24, 2017 through February 23, 2018;
- 10) Zuvid, LLC: valid February 24, 2017 through February 23, 2018;
- 11) Patriot Gaming & Electronics, Inc.: valid March 31, 2017 through March 30, 2018; and
- 12) TCS John Huxley Europe, Ltd.: valid March 19, 2017 through March 18, 2018

Each licensee must notify the Commission of its desire to be considered for a subsequent license renewal at least thirty days before the expiration of the license.
