

**ORDER 2021-7**  
**AN ORDER OF THE INDIANA GAMING COMMISSION**  
**CONCERNING RENEWAL OF SUPPLIER'S LICENSES**

In accordance with Ind. Code art. 4-33, Ind. Code art. 4-35, and 68 Ind. Admin. Code § 2-2, the Indiana Gaming Commission ("Commission") previously issued supplier's licenses to: (1) Amelco UK Limited; (2) IGT; (3) Halifax Security, Inc.; (4) Zuvid, LLC; (5) Data Financial, Inc.; (6) Incredible Technologies, Inc.; (7) Tony DeLeon and Associates, Inc. d/b/a Playersoft Technologies; (8) Interblock Luxury Gaming Products, D.D.; (9) TCS John Huxley Europe, LTD.; (10) Genesis Gaming Solutions, Inc.; (11) Midwest Game Supply Co.; (12) SG Gaming, Inc.; (13) Patriot Gaming and Electronics, Inc.;

A supplier's license is valid for a period of one year. Further, in accordance with Ind. Code § 4-33-7-8, a supplier's license must be renewed annually along with the payment of Seven Thousand Five Hundred Dollars (\$7,500.00) as an annual renewal fee. Each of these licensees has requested renewal and paid the required renewal fee. The Commission has determined that the above-named supplier licensees remain in substantial compliance with Ind. Code art. 4-33, Ind. Code art. 4-35, and Title 68 of the Indiana Administrative Code and are suitable to hold a supplier's license.

The Commission hereby **GRANTS** the renewal of the licenses of each of the following for a period of one year as specified below:

- 1) Amelco UK Limited: valid January 8, 2021 through January 7, 2022;
- 2) IGT: valid January 26, 2021 through January 25, 2022;
- 3) Halifax Security, Inc.: valid February 24, 2021 through February 23, 2022;
- 4) Zuvid, LLC: valid February 24, 2021 through February 23, 2022;
- 5) Data Financial, Inc.: valid March 4, 2021 through March 3, 2022;
- 6) Incredible Technologies, Inc.: valid March 4, 2021 through March 3, 2022;
- 7) Tony DeLeon and Associates, Inc. d/b/a Playersoft Technologies: valid March 8, 2021 through March 7, 2022;
- 8) Interblock Luxury Gaming Products, D.D.: valid March 19, 2021 through March 18, 2022;
- 9) TCS John Huxley Europe, Ltd.: valid March 19, 2021 through March 18, 2022;
- 10) Genesis Gaming Solutions, Inc.: valid March 23, 2021 through March 22, 2022;
- 11) Midwest Game Supply Co.: valid March 27, 2021 through March 26, 2022;
- 12) SG Gaming, INC.: valid March 28, 2021 through March 29, 2022;
- 13) Patriot Gaming and Electronics, Inc.: valid March 31, 2021 through March 30, 2022;

Each licensee must notify the Commission of its desire to be considered for subsequent license renewal at least thirty days before the expiration of the license.
