

ORDER 2023-53
AN ORDER OF THE INDIANA GAMING COMMISSION
CONCERNING RENEWAL OF SUPPLIER'S LICENSES

In accordance with Ind. Code art. 4-33, Ind. Code art. 4-35, Ind. Code art. 4-38 and 68 Ind. Admin. Code § 2-2, the Indiana Gaming Commission ("Commission") previously issued supplier's licenses to: (1) EDF Compliance d/b/a Odds On Compliance; (2) Bally's Interactive, LLC.; (3) White Hat Gaming; (4) Konami Gaming, Inc.; (5) Masque Publishing, Inc.; (6) Everi Payments, Inc.; (7) Ainsworth Game Technology; (8) United States Playing Card Company; (9) Novomatic America Sales, LLC; (10) NRT Technology Corp; (11) VICI Properties, Inc.; (12) Acres Manufacturing, Inc. (13) Kambi (Sports Information Services Limited).

A supplier's license is valid for a period of one year. Further, in accordance with Ind. Code § 4-33-7-8, a supplier's license must be renewed annually along with the payment of Seven Thousand Five Hundred Dollars (\$7,500.00) as an annual renewal fee. Each of these licensees has requested renewal and paid the required renewal fee. The Commission has determined that the above-named supplier licensees remain in substantial compliance with Ind. Code art. 4-33, Ind. Code art. 4-35, Ind. Code art. 4-38 and Title 68 of the Indiana Administrative Code and are suitable to hold a supplier's license.

The Commission hereby **GRANTS** the renewal of the licenses of each of the following for a period of one year as specified below:

- 1) EDF Compliance dba Odds On Compliance: valid April 26, 2023 through April 25, 2024;
- 2) Bally's Interactive, LLC.: valid May 24, 2023 through May 23, 2024;
- 3) White Hat Gaming: valid May 24, 2023 through May 23, 2024;
- 4) Konami Gaming, Inc.: valid May 29, 2023 through May 28, 2024;
- 5) Masque Publishing, Inc.: valid May 30, 2023 through May 29, 2024;
- 6) Everi Payments, Inc.: valid June 2, 2023 through June 1, 2024;
- 7) Ainsworth Game Technology: valid June 17, 2023 through June 16, 2024;
- 8) United States Playing Card Company: valid June 17, 2023 through June 16, 2024;
- 9) Novomatic America Sales, LLC: valid June 18, 2023 through June 17, 2024;
- 10) NRT Technology Corp.: valid June 23, 2023 through June 22, 2024;
- 11) VICI Properties, Inc.: valid June 29, 2023 through June 28, 2024;
- 12) Acres Manufacturing Inc.: valid June 30, 2023 through June 29, 2024; and
- 13) Kambi (Sports Information Services Limited): valid July 10, 2023 through July 9, 2024.

Each licensee must notify the Commission of its desire to be considered for subsequent license renewal at least thirty days before the expiration of the license.

According to Ind. Code ch. 4-21.5-3, this Order is effective fifteen days after it is served.
