

ORDER 2024-05
AN ORDER OF THE INDIANA GAMING COMMISSION
CONCERNING RENEWAL OF SUPPLIER'S LICENSES

In accordance with Ind. Code art. 4-33, Ind. Code art. 4-35, Ind. Code art. 4-38 and 68 Ind. Admin. Code § 2-2, the Indiana Gaming Commission ("Commission") previously issued supplier's licenses to: (1) IGT; (2) Halifax Security, Inc.; (3) Zuvid, LLC; (4) Data Financial, Inc.; (5) Incredible Technologies, Inc.; (6) Score Media and Gaming, Inc. dba TheScore; (7) ConnectionsIT, Inc.; (8) Interblock Luxury Gaming Products, D.D.; (9) TCS John Huxley Europe, LTD.; (10) Genesis Gaming Solutions, Inc.; (11) Amelco UK Limited; (12) SportRadar Solutions; (13) Surveillance System Integration; (14) LNW Gaming, Inc. d/b/a Light and Wonder; (15) Patriot Gaming and Electronics, Inc.; (16) Masque Publishing, Inc.

A supplier's license is valid for a period of one year. Further, in accordance with Ind. Code § 4-33-7-8, a supplier's license must be renewed annually along with the payment of Seven Thousand Five Hundred Dollars (\$7,500.00) as an annual renewal fee. Each of these licensees has requested renewal and paid the required renewal fee. The Commission has determined that the above-named supplier licensees remain in substantial compliance with Ind. Code art. 4-33, Ind. Code art. 4-35, Ind. Code art. 4-38, and Title 68 of the Indiana Administrative Code and are suitable to hold a supplier's license.


The Commission hereby **GRANTS** the renewal of the licenses of each of the following for a period of one year as specified below:

- 2) Halifax Security, Inc.: valid February 24, 2024 through February 23, 2025;
- 3) Zuvid, LLC: valid February 24, 2024 through February 23, 2025;
- 4) Data Financial, Inc.: valid March 4, 2024 through March 3, 2025;
- 5) Incredible Technologies, Inc.: valid March 4, 2024 through March 2, 2025;
- 6) Score Media and Gaming, Inc. dba TheScore: valid March 13, 2024 through March 12, 2025;
- 7) ConnectionsIT, Inc.: valid March 13, 2024 through March 12, 2025;
- 8) Interblock Luxury Gaming Products, D.D.: valid March 19, 2024 through March 18, 2025;
- 9) TCS John Huxley Europe, Ltd.: valid March 19, 2024 through March 18, 2025;
- 10) Genesis Gaming Solutions, Inc.: valid March 23, 2024 through March 22, 2025;
- 11) Amelco UK Limited: valid March 23, 2024 through March 22, 2025;
- 12) SportRadar Solutions: valid March 23, 2024 through March 22, 2025;
- 13) Surveillance System Integration: valid March 23, 2024 through March 22, 2025;
- 14) LNW Gaming, Inc. d/b/a Light and Wonder.: valid March 29, 2024 through March 28, 2025;
- 15) Patriot Gaming and Electronics, Inc.: valid March 31, 2024 through March 30, 2025; and
- 16) Masque Publishing, Inc.: valid May 30, 2024 through May 29, 2025.


Each licensee must notify the Commission of its desire to be considered for subsequent license renewal at least thirty days before the expiration of the license.
