Commission Meeting

Ameristar East Chicago and Hollywood Casino:

- Granted a waiver to utilize a modified craps game. 68-IAC 10-4-1.

Belterra Casino

- Granted a permanent waiver on surveillance staffing. 68 IAC 12-1-1.7(a).

Belterra Casino and Blue Chip Casino:

- Granted a waiver to increase the threshold on TITO ticket redemption on self-redemption kiosks.

Caesars Southern Indiana:

- Granted a waiver to increase the threshold for checks cashed utilizing a check guarantee service. 68 IAC 16-1-10(b)(2).
- Granted a permanent waiver on maintenance of found cash equivalents. 68 IAC 15-1-4.1.
- Granted a waiver to forego the display of gaming badges for steakhouse employees only. 68 IAC 2-3-5 (f)4(B).

Hard Rock Northern Indiana:

- Granted a temporary waiver to utilize two (2) reserve sets of non-value chips for two (2) new Roulette games. 68 IAC 14-4-3.

Harrah's Hoosier Park:

- Granted a waiver for a 90-day trial to alleviate the requirement for a second verifier on manually paid jackpots under certain conditions. 68 IAC 15-13-2(d)(7).

Horseshoe Hammond

- Granted a waiver to allow underage performers in The Venue on December 1, 2023, and December 9, 2023. 68 IAC 1-11-1(c).

Horseshoe Indianapolis:

- Granted relief on utilizing a wheel head lock on the Roulette wheel cover. 68 IAC 14-7-4(l).
- Granted a waiver on the requirement to have a dedicated Level 1 Sports Wagering Manager. 68 IAC 27-2-18.

Terre Haute Resort Casino

- Granted a waiver to utilize blackjack layouts with 5, 6 and 7 wagering spots. 68 IAC 14-6-2(b)(3).
- Granted a waiver to utilize 6 to 5 odds at blackjack. 68 IAC 10-2-5(b).
- Granted a waiver to utilize a \$2 chip. 68 IAC 14-4-4(5).
- Granted a waiver on cutting the card at Baccarat and Mini-Baccarat. 68 IAC 10-10-8(c).
- Granted a waiver on burning a card for a face up card found in a Baccarat shoe. 68 IAC 10-10-17(b).
- Granted a waiver to utilize an electronic machine entry authorization log (MEAL). 68 IAC 2-6-2(e).
- Granted a waiver to utilize pre-shuffled cards. 68 IAC 14-3-2(b)(11).
- Granted a waiver for touching and altering cards at Baccarat. 68 IAC 10-10-10(c).
- Granted a waiver on the staffing of the sports wagering kiosk drop process. 24-hour Gaming Operations Plan.
- Granted a waiver on dedicated surveillance coverage for progressive electronic gaming devices. 68 IAC 12-1-5(f)(6)(A) and 68 IAC 12-1-5(f)(6)(B).
