The Wage and Hour Division of the U.S. Department of Labor is responsible for conducting wage surveys to establish the wage rates applicable to construction projects that fall within the jurisdiction of the Davis-Bacon and Related Acts. The Davis-Bacon and Related Acts require payment of locally prevailing wage rates and fringe benefits to employees of contractors and subcontractors performing work on federally financed or assisted construction projects.

**A residential wage survey has been initiated for the state of Indiana.** The **Indiana residential** construction survey will solicit information on wages and fringe benefits paid on projects that were active and ongoing between **08/01/2017 and 07/31/2018**.
