

Dear Administrator Regan,

As the Director of the agency that will respond to the Solar for All, I am writing today in support of the Indiana Housing and Community Development Authority's (IHCDA) "Solar for All" application for funding.

IHCDA currently administers large Federal grants from Health and Human Services (LIHEAP), Department of Energy (Weatherization Assistance Program), Department of Housing and Urban Development (various Lead programs, Healthy Homes), the Emergency Rental Assistance Program, and the Homeowner's Assistance Fund, among others.
