A written report of the assessment of damages shall be mailed to the aggrieved party and the department by first class United States mail. If either the department or the aggrieved party is not satisfied with the assessment of damages, either or both may file a petition, not later than fifteen (15) days after receiving the report, in the circuit or superior court of the county in which the land or water is located.



Introduction

This Public Involvement Plan (PIP) has been developed for the proposed State Route (SR) 912 and Michigan Avenue Bridges project in Lake County, Indiana Des. 1800067 (Lead) by the consulting firm Parsons Transportation Group ("Parsons"), on behalf of the Indiana Department of Transportation (INDOT). The purpose of this plan is to establish the goals and strategies for engaging with the public and key stakeholders in accordance with the current INDOT Project Development Public Involvement Procedures Manual (July 7, 2021). Successful public involvement establishes communication between the public and INDOT in order to integrate the views, community concerns, transportation needs, and environmental considerations of the public into the transportation decision-making process.

Project Description

The project is located at the SR 912 and Michigan Avenue interchange, 1.34 miles west of US 12, in the City of East Chicago, Lake County, Indiana. The project contains five roadway bridges and one pedestrian bridge that are part of an interchange. The interchange is the main entrance into the Cleveland-Cliffs Indiana Harbor steel plant and provides alternate access to the Ameristar Casino, Jeorse Park, and other lakefront facilities. The project is located in a highly developed urban area of East Chicago surrounded by industrial, commercial, and residential properties.

The current recommended alternative includes reconstruction of the seven-span Michigan Avenue bridge over SR 912, ramps, and three railroads: Norfolk Southern, Indiana Harbor Belt and Wisconsin Central, and Amtrak. A new roundabout on the southern portion of the interchange is proposed. The southern ramps, Ramp H and Ramp B, will be realigned, and the Ramp H and Ramp B over Ramp B bridges will be removed. Existing retaining walls will be removed and replaced with embankments and/or walls. The northern ramps, Ramp NEC and Ramp I, and their bridges will be rehabilitated. Existing pavement, curb and gutter will be repaired or replaced as needed. A closed pedestrian bridge over the railroads will be removed. Additionally, drainage issues south of SR 912 will be addressed with new inlet structures and curb cuts. Replacement of overhead sign structures and installation of a new roundabout lighting system is also anticipated.

The recommended alternative would require approximately 0.79 acre of temporary right-of-way and approximately 0.11 acre of right-of-way reacquisition.

The maintenance of traffic (MOT) includes closure of the Michigan Avenue bridge and a detour will be provided. The goal will be to expedite construction sequencing and identify ways to reduce closure time to traffic. Construction is anticipated to begin in February 2023.

An analysis of environmental impacts is underway as part of the National Environmental Protection Act (NEPA) process. The *Historic Bridges Programmatic Agreement* ¹ (HBPA) and Section 4(f) applies to this project. The Ramp B over B Bridge (Structure No. 912-45-06596 B; NBI No. 33035), is included in the *Indiana Historic Bridge Inventory*, which recommended the bridge eligible for the National Register of Historic Places (NRHP) and designated it as Non-Select. The bridge was determined eligible under Criterion C as it represents "an early or distinctive phase in bridge construction, design, or engineering, and it retains the historic integrity necessary to convey its engineering significance". This draft PIP was prepared with the assumption that the historic bridge would be replaced (because both rehabilitation and relocation are not likely feasible and prudent, based on the current draft Alternatives Analysis). This PIP will be updated if the scope of work changes.

Natural resource impacts are minimal due to the urban setting. Based on anticipated environmental impacts, the project would be a Categorical Exclusion, Level 4 (CE-4) environmental document due to the historic bridge and proposed "permanent traffic pattern alteration".

Goals for the Public Involvement Plan

INDOT recognizes that public involvement is a key component in the success of any transportation project and understands the importance of information exchange when providing transportation facilities and services to the East Chicago community. Area residents, businesses, and visitors rely on a safe and dependable transportation network to travel throughout the community, the region, and the state. The Team leading public involvement efforts for this project consists of INDOT Central Office, INDOT LaPorte District Customer Service, and Parsons staff who will manage the public involvement and agency coordination activities outlined in this document.

The public involvement process begins with coordination between the Team, local officials, and other stakeholders that will be involved with the project. Initial coordination meetings with local officials will include information on the scope and schedule of the project, as well as an opportunity to discuss potential project impacts as they relate to their jurisdiction. The process continues by providing information to these same stakeholders and keeping them informed of the project's direction.

The use of virtual public involvement methods will broaden public participation and promote safe and prudent practices, particularly during emergencies, in a manner that meets all federal and state public involvement requirements. Environmental Justice (EJ) Outreach

Federal law, including Title VI of the Civil Rights Act of 1964, the Federal Highway Act of 1973, and the Age Discrimination Act of 1975, prohibits discrimination on the basis of race, color, national origin, gender, and age and Executive Order 12898 obligates Federal actions (those receiving federal funding) to avoid or minimize and mitigate adverse impacts to low-income and minority populations and to assure that disproportionately high and adverse impacts on these populations are identified and addressed.

Based on initial research, the project area contains minority and low-income EJ populations. The USHUD Resource Locator mapping tool (https://resources.hud.gov/) lists 19 multifamily public housing units are within 0.5 mile of the project area.

Community contacts, activity centers, churches, and social service organizations serving these populations will be included on the project mailing list and provided with project information including public involvement activities and key project milestones. If disproportionate impacts to the EJ populations are identified; INDOT may conduct focused outreach events, such as kitchen table meetings or community presentations.

Communication Methods

Notifications

Early Coordination

Early coordination, including Notice of Entry Letters, Section 106 consulting party coordination, and coordination with regulatory agencies and other stakeholders, will be conducted in accordance with current INDOT policies.

Bridge Marketing and Availability Notification

The HBPA requires the owners of historic bridges to place a legal notice in both a local newspaper and a statewide newspaper a minimum of six (6) months in advance of the public hearing to notify interested parties that a historic bridge is available for re-use. The advertisement will describe the length, width, height, condition, and availability of the bridge.

Along with the published notification, signs will be placed at both bridge approaches a minimum of six (6) months in advance of the public hearing to notify users that the historic bridge will be replaced and the signs will remain in place until completion of the NEPA process. Information will also be provided to the CRO for posting to INDOT's Historic Bridges Marketing Program website a minimum six (6) months prior to the public hearing. INDOT will forward the information to the Indiana Landmarks to post on their website if they choose to do so.

Press Releases

Press releases will be developed and distributed to local media outlets and posted on INDOT social media platforms and website at key project milestones. This will be the primary method for informing and involving a wide public audience.

Project Website

Project-related information will be posted on INDOT's project website to provide the public with the most current project information. The website will contain the latest updates, project schedule, maps, documents,

and any upcoming meeting dates as well as Project Team contact information, resource agency links, and options for providing comments.

Meetings

Section 106 Process and Consulting Party Meeting(s)

Section 106 meetings with consulting parties may be conducted to discuss the project's historic and archaeological reports, Alternatives Analysis, Effect Findings, and/or memorandum of agreement (MOA). Based on initial project feedback from early coordination, no controversy is expected and there is little interest in the potential removal of the historic Ramp B over B bridge (see photograph on cover page). Currently up to two consulting party meetings may by held if they are requested by IDNR DHPA or other stakeholders. Additionally, the public will be informed of the proposed findings and will have opportunities to comment via the required public notices for Section 106 and Section 4(f), as well as the proposed Public Hearing.

Other Meetings

At this time, other stakeholder meetings such as community advisory committees, noise meetings, EJ-focus groups, etc., are not proposed. This does not preclude INDOT from hosting such meetings should they be needed.

Public Hearing

The Public Hearing is an opportunity for the public to make formal statements of their views on the project immediately before project decision-making. The Public Hearing will be held once preliminary plans have been developed and a draft environmental document has been approved by INDOT. The Public Hearing will be advertised twice in the legal notice section of at least one local newspaper: the *Times of Northwest Indiana*. The first notice will be published at least 15 days before the hearing. The second notice will be published 7 days before the hearing. The hearing will also be noticed on the project website and a press release will be distributed to local media. The notices will specify the date, time, place, and purpose of the hearing. It will include a brief project description and announce the locations where the environmental document is available for viewing (website and local repositories). The notice will include contact information for requesting assistance for persons with disabilities or communication barriers. Local repositories are anticipated to be the LaPorte District office and the Main Library of the East Chicago Public Library.

The Public Hearing will be held at a place and time generally convenient for people affected by or interested in the project and at a location accessible to people with disabilities. At the hearing, the Team will have an Open House session prior to the formal presentation. This Open House session will allow the public and stakeholders to speak with the Team and ask project related questions. Various large display boards will be on view, as well as handouts with project information, copies of the draft environmental document, and design plans. Following the Open House session, there will be a formal presentation by the Team, which will include the following information:

- The project's purpose and need
- The project schedule, including major milestones, phasing, and anticipated construction start and end dates
- Estimated construction cost
- The Maintenance of Traffic plan
- The project's alternatives and major design features
- The social, economic, environmental, and other impacts of the project
- The availability of the environmental document
- Procedures for the public to make verbal and written statements about the project

INDOT is committed to providing a Public Hearing format that allows full public participation. After the formal presentation, there will be a Question & Answer session, so the Team can answer any project-related questions. The public and other stakeholders will then have an opportunity to make a formal comment about the project in the following ways:

- · Public statements at the hearing
- Verbal comments made privately during the meeting to a recording device
- · Written comments will be accepted in person at the Public Hearing
- 30-day public comment period following the hearing the public and other stakeholders, including stakeholders who did not attend the Public Hearing, may submit comments to the Team via mail or email

A transcript will be made of all verbal statements and comments made at the Public Hearing. The transcript will include copies of all written statements from the public, both those submitted at the public hearing and during the 30-day public comment period following the hearing. A summary of the Public Hearing proceedings and responses to all substantive comments will be included in the final environmental document for the project.

The Indiana Department of Transportation (INDOT) will host a public hearing on Tuesday, September 27, 2022 at Ivy Tech East Chicago Campus – 410 E Columbus Dr, East Chicago, IN 46312, the hearing will begin at 6:00 p.m. The purpose of the public hearing is to offer all interested persons an opportunity to comment on current preliminary design plans, the environmental document, and Section 106 document for the SR 912 and Michigan Avenue Bridges Project in Lake County. Doors will open at 5:00 p.m. and project team members will be available before and following the formal hearing procedure.

The primary needs for the project stem from the deteriorated condition of the six existing bridges and roadway pavement within the interchange. The primary purpose of the project is to extend the life of the interchange by: restoring the vehicular bridges to at least good condition; improving the condition and extending the service life of roadway and bridge approach pavement by at least 20 years; correcting cracked/settled retaining walls and providing a median barrier along SR 912 that meets current standards; and eliminating the concerns associated with the closed pedestrian bridge.

The project is located at the SR 912 and Michigan Avenue interchange, 1.34 miles west of US 12. The project contains five roadway bridges and one closed pedestrian bridge that are part of an interchange. The interchange is the main entrance into the Cleveland-Cliffs Indiana Harbor steel plant and provides alternate access to the Ameristar Casino, Jeorse Beach Park, and other lakefront facilities.

The project proposes to replace the Michigan Avenue Bridge which spans SR 912, ramps, and three railroads, and install a new roundabout on the southern portion of the interchange. The southern ramps (Ramp H and Ramp B) will be realigned, and their bridges will be removed. The northern ramps (Ramp NEC and Ramp I) and their bridges will be rehabilitated. Existing retaining walls will be removed and replaced with embankments and/or walls. Existing pavement will be repaired or replaced as needed. A closed pedestrian bridge over the railroads will be removed. Drainage improvements, replacement of overhead sign structures, and installation of a new roundabout lighting system are also proposed.

Construction is anticipated to begin in Spring of 2024. During the reconstruction, the Michigan Avenue Bridge will be closed for approximately two years. Maintenance of traffic details will be presented during the public hearing. Access to all properties will be maintained during construction. INDOT will coordinate with emergency services, public transit, local school corporation officials, and project stakeholders to ensure potential disruptions and impacts are minimized as much as possible.

PROJECT DESCRIPTION

The project is located at the SR 912 and Michigan Avenue interchange, 1.34 miles west of US 12, in the City of East Chicago, Lake County, Indiana. The project contains five roadway bridges and one pedestrian bridge that are part of an interchange. The interchange is the main entrance into the Cleveland-Cliffs Indiana Harbor steel plant and provides alternate access to the Ameristar Casino, Jeorse Park, and other lakefront facilities.

The project proposes to reconstruct the seven-span Michigan Avenue bridge which spans SR 912, several ramps, and three railroads (Norfolk Southern, Indiana Harbor Belt and Wisconsin Central, and Amtrak) and install a new roundabout on the southern portion of the interchange. The southern ramps (Ramp H and Ramp B) will be realigned, and their bridges will be removed. The northern ramps (Ramp NEC and Ramp I) and their bridges will be rehabilitated. Existing retaining walls will be removed and replaced with embankments and/or walls. The existing pavement, curb and gutter will be repaired or replaced as needed. A closed pedestrian bridge over the railroads will be removed. Additionally, drainage issues south of SR 912 will be addressed with new inlet structures and curb cuts. Replacement of overhead sign structures and installation of a new roundabout lighting system is also proposed.

During the reconstruction, the Michigan Avenue Bridge will be closed and a detour will be provided. The goal is to expedite construction and identify ways to reduce closure time. Construction is anticipated to begin in Spring of 2023.

As part of the project, an analysis of environmental and socioeconomic impacts was conducted as part of the National Environmental Protection Act (NEPA) process. During the analysis, it was determined that the Historic Bridges Programmatic Agreement 1 (HBPA) and Section 4(f) applies to this project. The Ramp B over B Bridge (Structure No. 912-45-06596 B; NBI No. 33035), is included in the Indiana Historic Bridge Inventory, which determined that the bridge was eligible for the National Register of Historic Places (NRHP) and designated it as Non-Select. The bridge was determined eligible under Criterion C as it represents "an early or distinctive phase in bridge construction, design, or engineering, and it retains the historic integrity necessary to convey its engineering significance".



The Indiana Department of Transportation (INDOT) has developed proposed improvements for the State Road (SR) 912/Michigan Avenue interchange. The project is located approximately 1.3 miles east of the Cline Avenue Bridge, beginning southwest of the Ramp B over B Bridge and ending approximately 215 feet north of the Michigan Avenue Bridge.

The proposed improvements would increase the function and safety of the interchange, extend pavement service life, and address existing design deficiencies such as narrow shoulders, low bridges, and limited sight distances.

The proposed improvements include constructing a new roundabout at the SR 912/Michigan Avenue interchange; replacing the Michigan Avenue bridge over SR 912; removing three bridges (the Ramp H over B bridge, Ramp B over Ramp B bridge, and a non-functional pedestrian bridge); rehabilitating two bridges (Ramp NEC and bridge and Ramp I and bridge); and realigning three ramps (Ramps G, H, and B) (**Figure 1**).

Maintenance of Traffic


During construction, the maintenance of traffic activities will occur in two phases, each spanning approximately one year (**Figure 2**). During <u>Phase 1</u>, the SR 912/Michigan Avenue interchange and the bridge over SR 912 will be closed. Access to the East Chicago Marina, Ameristar Casino, Jeorse Park, and industrial areas will be maintained via Ramp I and Ramp NEC (see inset image). During <u>Phase 2</u>, the SR 912/Michigan Avenue interchange and the bridge over SR 912 will remain closed and Ramps I and NEC will also be closed. During Phase 2, access to the Marina, Hotel, Park, and industrial areas will be limited to the Ameristar Casino Interchange via Ramps 5C, 5D, and 5V (**Figure 2**). SR 912 will remain open to traffic during all construction phases.

Historic Resources

Two historic resources were identified during the study. The Inland Steel Building (Figure 3), built in 1930, is an excellent example of art deco architecture and has been determined eligible for listing in the National Register of Historic Places. Following a review by the State Historic Preservation Office (SHPO), it was determined that the project would have no adverse effects on this resource.

The Ramp B over B bridge (Figure 4), a historic bridge listing candidate, will be removed as part of the proposed improvements. INDOT and SHPO conducted an in-depth review using criteria established in the State's Historic Bridge Programmatic Agreement and determined the bridge to be "Non-Select", and unsuitable for preservation. When an Indiana historic bridge is planned for bypassing or replacement, the bridge is offered to any group or individual that may want to take ownership of the bridge and manage it in place or relocate it to another site. The Ramp B over B bridge has been advertised for reuse in local newspapers, through on-site signage, and is currently being marketed on the INDOT Historic Bridge Program website.

The Eastern Shawnee Tribe is committed to protecting sites important to Tribal Heritage, Culture and Religion. Furthermore, the Tribe is particularly concerned with historical sites that may contain but not limited to the burial(s) of human remains and associated funerary objects.

As described in your correspondence, and upon research of our database(s) and files, we find our people occupied these areas historically and/or prehistorically. However, the project proposes **NO Adverse Effect** or endangerment to known sites of interest to the Eastern Shawnee Tribe. Please continue project as planned. However, should this project inadvertently discover an archeological site or object(s) we request that you immediately contact the Eastern Shawnee Tribe, as well as the appropriate state agencies (within 24 hours). We also ask that all ground disturbing activity stop until the Tribe and State agencies are consulted. Please note that any future changes to this project will require additional consultation.

In accordance with the NHPA of 1966 (16 U.S.C. § 470-470w-6), federally funded, licensed, or permitted undertakings that are subject to the Section 106 review process must determine effects to significant historic properties. As clarified in Section 101(d)(6)(A-B), historic properties may have religious and/or cultural significance to Indian Tribes. Section 106 of NHPA requires Federal agencies to consider the effects of their actions on all significant historic properties (36 CFR Part 800) as does the National Environmental Policy Act of 1969 (43 U.S.C. § 4321-4347 and 40 CFR § 1501.7(a).
