LEGAL NOTICE OF PLANNED IMPROVEMENT

The Indiana Department of Transportation (INDOT) is developing plans for proposed State Route (SR) 9 and County Road (CR) 600 N Intersection Improvements with Added Turn Lane in Madison County.

The purpose of this project is to improve the safety of the SR 9 and CR 600 N intersection and reduce the number of crashes at this intersection. The need for the project is due to the elevated number of angle crashes and high-speed rear end crashes that indicate the existing traffic signal is not sufficiently and safely controlling traffic at this intersection.

This project proposes to modify the existing intersection by providing enhanced signal visibility and modernized configuration. This project will include, but is not limited to, installing additional lighting, installing a flasher warning system, creating positive offset left turn lanes, replacing signal heads, extending existing culverts, and ditch grading to ensure proper drainage.

All work will occur within the existing road right-of-way. No relocations of residences or businesses will occur.

The maintenance of traffic (MOT) plan proposes closing one lane in each direction along SR 9 while still maintaining one lane in each direction. Access to all properties will be maintained throughout construction. School corporations and emergency services will be notified of closures prior to construction. The proposed start of construction is 2024.

The cost associated with this project is approximately \$1.6 million which includes preliminary engineering, right-of-way, and construction, with both federal and state funds anticipated to be used. The Federal Highway Administration (FHWA) and INDOT have agreed this project falls within the guidelines of a Categorical Exclusion (CE) Level 1 document.
