LEGAL NOTICE OF PUBLIC HEARING

Proposed Improvement, Roundabout at US 36 and Raider Road in Henry County

The Indiana Department of Transportation (INDOT) will host a public hearing on Thursday, January 18, 2024, at Shenandoah High School (7354 US 36, Middletown, IN 47356). Materials will be available for review from 5:30 p.m. until 7:00 p.m. A presentation will be held at 6:00 p.m. and formal comments will be taken immediately following the presentation. The purpose of the public hearing is to offer all interested persons an opportunity to comment on current preliminary design plans to the proposed roundabout intersection of US 36 and Raider Road in Middletown in Henry County (Des. #2000152). The purpose of the project is to reduce crash frequency and severity at the intersection.

As proposed, the project involves the construction of a single lane roundabout at the intersection of US 36 and Raider Road. The existing signal infrastructure will be removed, and new signing and lighting will be added. Each approach leg will have a splitter island to separate and manage traffic approaching the center island. Each quadrant of the intersection will have an exterior truck apron, and the central island will have a truck apron.

The Maintenance of Traffic (MOT) plan for the project involves closures of Raider Road and US 36 at the intersection, with detours provided on State Routes. Access to Shenandoah High School and local drives will be maintained. MOT details will be presented during the public hearing. Access to all properties will be maintained during construction. INDOT will coordinate with emergency services, local school corporation officials and project stakeholders to ensure potential disruptions and impacts are minimized as much as possible. The project will require approximately 1.8 acres of permanent new right-of-way, in addition to 0.13 acres of temporary right-of-way needed during construction. No impacts to wetlands or residential relocations are required for the project. Construction is expected to begin in June 2025. The estimated construction cost is approximately \$2.23 million.

Federal and state funds are proposed to be used for construction of this project. INDOT and the Federal Highway Administration have agreed that this project poses minimal impact to natural environment. A Categorical Exclusion (CE) environmental document has been prepared for the project. Public statements for the record will be taken as part of the public hearing procedure. The proposed action does not impact properties listed in or eligible for the National Register of Historic Places (NRHP).
