Resolution Number 10-IMPO-001

A RESOLUTION amending the 2009-2012 Indianapolis Regional Transportation Improvement Program.

WHEREAS, the 2009-2012 Indianapolis Regional Transportation Improvement Program (IRTIP) incorporates projects proposed by local governments and agencies within the Indianapolis Metropolitan Planning Area; and

WHEREAS, the projects contained in the proposed IRTIP amendment have been reviewed as to their immediate impact and importance to the continued improvement of the transportation system operating within the area; and

WHEREAS, changing conditions necessitate periodic amendments to the IRTIP; and

WHEREAS, section 176(c) of the Clean Air Act, amended in 1990, required that the Transportation Conformity Rule establish criteria and procedures by which the Federal Highway Administration (FHWA), the Federal Transit Administration (FTA), and metropolitan planning organizations (MPOs) determine the conformity of federally funded or approved highway and transit plans, programs, and projects to state implementation plans (SIPs) prepared for criteria pollutants; and

WHEREAS, the MPO consulted with the Interagency Consultation Group and the agencies did not take exception to the MPO finding that (1) each project in the TIP as amended is consistent with the design concept and scope of the project that was modeled in the most recent conformity demonstration, (2) the open-to-traffic date of each project in the TIP as amended is consistent with the open-to-traffic dates in the most recent conformity demonstration, (3) that the previous emissions analysis meets the requirements of 40 CFR 93.118 and demonstrate conformity of the TIP as amended; and

WHEREAS, the proposed IRTIP amendments were made available for public comment and comments received were provided to the Indianapolis Regional Transportation Council Policy Committee (IRTC); and

WHEREAS, the IRTC Policy Committee is the approval body for all transportation-related activities of the Metropolitan Planning Organization for the Indianapolis Urbanized Area under applicable U.S. Department of Transportation regulations;

NOW, THEREFORE, BE IT RESOLVED, that the IRTC hereby approves the amendment to the <u>2009-2012 Indianapolis Regional Transportation Improvement Program</u> as shown on the attached Exhibit A.

2009-2012 IRTIP Proposed First Quarter 2010 Amendments

Modify the following projects in the 2009-2012 IRTIP as described below:

EXEMPT PROJECTS:

Indiana Department of Transportation (INDOT):



DES # 0901964 – Bridge maintenance and repair on four bridges in Marion County with a total cost of \$100,000 (\$80,000 federal and \$20,000 state match). Add CN to FY 2010.



DES # 0902024 – Demolition of building/foundation on Parcel 8 along US 40 in Hancock County with a total cost of \$20,000 (\$16,000 federal and \$4,000 state match). Add CN to FY 2011.



DES # 0902009 – Demolition of building/foundation on SR 135 near Stones Crossing in Johnson County with a total cost of \$75,000 (\$60,000 federal and \$15,000 state match). Add CN to FY 2010.



DES # 0900234 – HMA overlay/preventative maintenance on SR 135 from SR 252 to SR 144 in Johnson County, with a total cost of \$998,122 (\$798,498 federal and \$199,624 state match). Add CN to FY 2010.



DES # 0710890 – Bridge deck replacement on SR 37 .03 miles south of SR 144, southbound lanes, in Johnson County with a total cost of \$750,000 (\$600,000 federal and \$150,000 state match). Add CN to FY 2011.

DES # 0710891 - Bridge deck replacement on SR 37 .03 miles south of SR 144, northbound lanes, in Johnson County, with a total cost of \$750,000 (\$600,000 federal and \$150,000 state match). Add CN to FY 2011.

DES # 0900282 – Automated Traffic Management System deployment on I-465 and I-69 in Hamilton and Marion Counties with a total cost of \$6,254,000 (\$5,628,600 federal and \$625,400 state match). Add CN to FY 2010.



DES # 0810032 – Sign modernization on I-65 from mile marker 49 to mile marker 99 in Johnson County with a total cost of \$950,000 to be funded 100% with federal funds. Add CN to FY 2010.
