We have reviewed the State Transportation Improvement Program (STIP) amendment request you submitted via correspondence dated January 23, 2018. This request adds projects pursuant to changes made to the Transportation Improvement Program (TIP) for the:

- Northeastern Indiana Regional Coordinating Council (NIRCC)
- Delaware-Muncie Metropolitan Plan Commission (DMMPC)
- Area Plan Commission of Tippecanoe County (APC)
- Michiana Area Council of Governments (MACOG)
