INDOT is withdrawing STIP Amendment 18-18 dated on April 18, 2018.

INDOT is resubmitting STIP amendment 18-18 after removing non-exempt project amendments that are subject to the 1997 Ozone NAAQS. Those non-exempt projects will be amended into the STIP at a later date after a conformity determination for the 1997 Ozone NAAQs has been completed. This action is being taken in response to the February 16, 2018 U.S. Court of Appeals decision in the South Coast Air Quality Management District v. EPA, No. 15-1115, which struck down portions of the 2008 Ozone NAAQS SIP Requirements Rule concerning the ozone National Ambient Air Quality Standards.

The DES numbers that were removed STIP Amendment 18-18 dated on April 18, 2018 were 1801375 in Greene County, 1700728 in Hamilton County, and 1700167 in Warrick County.

The Indiana Department of Transportation requests the projects listed in STIP Amendment 18-18 to be incorporated into the 2018-2021 Statewide Transportation Improvement Program (STIP).

The required Metropolitan Planning Organization (MPO) Transportation Improvement Program (TIP) documents have been included in this request and duly noted in the Amendment. We have determined that the proposed amendments are: 1) consistent with the transportation plan; 2) the TIP remains fiscally constrained in that federal funding resources are sufficient to support the new or modified projects; and 3) conform to state and national air quality standards.

A draft of this amendment was posted on INDOT's STIP website <u>http://www.in.gov/indot/STIP</u> for comments. No comments were given about any project listed.
