Re: FY 2008-2011 STIP Transit Amendments #29, #30, and #31

Dear Mr. Buckel:

This letter responds to your three (3) letters, two (2) dated April 28, 2009 and one (1) dated May 14, 2009, requesting to amend the FY 2008 - 2011 Indiana Statewide Transportation Improvement Program (STIP). The amendments incorporate programming revisions made to the Northeastern Indiana Regional Coordinating Council's FY 2009 - 2012 Transportation Improvement Program, the Bloomington — Monroe County Metropolitan Planning Organization's FY 2009 - 2012 Transportation Improvement Program, and the Columbus Area Metropolitan Planning Organization's SFY 2009 - 2013 Transportation Improvement Program. The attached tables include only the FY 2009 projects that have been submitted to the FTA for approval. (Note: Administrative Modifications do not require FTA approval.) Projects in program years beyond FY 2009, that remain as viable projects, will be included in the approved and published TIPs and STIPs for the subsequent fiscal years.

We have determined that all of the FY 2009 transit projects included in these STIP amendments are financially constrained, and that the projects are consistent with the MPOs' and the State's Transportation Plans. We also find that the above TIPs are the result of Metropolitan Transportation Planning processes that substantially comply with the requirements of 23 CFR 450. In accordance with 23 CFR 450.220, we approve these STIP amendments.
